## **NOTES:**

- 1. Permission for a proposed road closure may be granted, granted with specific conditions or refused.**
- 2. Wicklow County Council may attach conditions to any road closure that may be granted. Any breach of these conditions may result in the withdrawal of permission for a road closure.**
- 3. An application for a road closure must be submitted to Wicklow County Council a minimum of 8 weeks prior to the proposed road closure.**
- 4. Applicants for a road closure must liaise with the Area Engineer/ Overseer, Town Council (if applicable) and The Garda Siochana in respect of any road closure.**
- 5. The applicant(s) should also endeavour to notify any residents affected by a proposed road closure.**
- 6. A map or detailed sketch of the road(s) affected should be submitted with the application.**
- 7. If the application is successful, Wicklow County Council must place a minimum of two advertisements in a newspaper circulating in the locality of the proposed road closures.**
- 8. The applicant(s) will be responsible for reimbursing Wicklow County Council any costs associated with placing these advertisements.**
- 9. Wicklow County Council will endeavour to use local newspapers to cut down on costs for the applicant(s).**
- 10. If any observations or objections in respect of the proposed road closure are received the applicant(s) will be notified. It is the responsibility of the applicant(s) to resolve any issues or problems that may arise.**
- 11. All information must be provided by the applicant(s) as only the roads, dates and times specified in the advertisements will be permitted.**
- 12. In the event of the road closure being cancelled or postponed, Wicklow County Council and the Garda Siochana must be notified as soon as possible.**
