€3 MILLION IN FUNDING FOR A NEW LIBRARY AT BALLYWALTRIM IN BRAY

Wicklow County Council has welcomed the announcement from Minister Heather Humphries yesterday with the confirmation that a maximum grant of €3 million euro has been allocated for a new library at Ballywaltrim. This substantial investment will mean the existing Ballywaltrim Library will almost quadruple in size and provide a modern public library space for the community.

Proposals for the major €3 million revamp of Ballywaltrim Library were given the green light back in February 2022 and are included among the capital projects contained within Wicklow County Library Service Development Plan 2021 to 2025.

Other ideas considered at the time included extending Bray Carnegie Library on Eglinton Road, however due to its historical significance and location with the prospect of losing the garden, it was agreed that the site at Ballywaltrim presented a better opportunity for development.

Like all *Rural Regeneration and Development Fund* (*RRDF*) funded libraries, the new Ballywaltrim Library will be a My Open Library whereby the public will have access from 8am to 10pm, seven days a week, 365 days a year.

FINALISTS ANNOUNCED FOR TOP STUDENT ENTERPRISE AWARDS

Over 80 of Ireland's brightest young entrepreneurial minds will compete in the finals of the Student Enterprise Programme from the 26,000 or so who began their businesses in September. A selection of the finalists joined Student Enterprise Programme Ambassador and radio and TV star Louise Cantillon in Dublin for the announcement.

The initiative of the Local Enterprise Offices has seen almost 400,000 secondary school students take part since it began in 2003. The 81 shortlisted businesses will exhibit at the National Finals on the 9th May in Mullingar where winners will be announced across the three categories of senior, intermediate and junior and one business will be named Student Enterprise of the Year for 2024.

The Finalists cover all sectors of business from seaweed harvesting and medical identification to farm safety and portable cranes. For the programme, each student enterprise is challenged with creating, setting up and running their own business, and must show viable sales of their service or product.

The Student Enterprise Programme is open to students of all ages at senior level, with three separate categories - Junior (1st year), Intermediate (2nd and 3rd year) and Senior (4th, 5th and 6th year, LVA, LCA and Youth Outreach). There are also a number of prizes that recognise achievements across specific categories – including the "Best Business Website", "Sustainability Award", the "Smart Business Idea", the "My Entrepreneurial Journey", "Finance Award", "Technology Award" and "Intellectual Property" competitions from previous years.

This year also marks the re-launch of the student workbooks 'as Gaeilge', further encouraging participation amongst Gaelscoil students while supporting the promotion of the Irish language.

The overall vacancy rate for rental properties (private and social) on Census night was 7%, so our vacancy rate is less than half the overall rate for a rental sector where Local Authorities account for only 29.8% of the properties. Also, Wicklow Co Co's vacant units only account for 3.2% of the total number of vacant units in our county.

Housing Maintenance

The Planned Maintenance funding allocation from the Department of Housing, Heritage, and Local Government for 2024 is €173,000, however there is still €185,000 which was spent on boiler replacements in 2023 which was invoiced too late for us to claim in 2023. This amount will have to come out of the 2024 allocation, and we continue to press the Department for an increase in the allocation to allow us to continue with much needed Planned Maintenance in 2024. The focus in 2024 will be on upgrading electrical installations in our pre 1990s housing stock.

Capital Assistance Scheme (CAS)

Wicklow County Council is continuing to support acquisitions under the Capital Assistance Scheme with Dublin Simon, Circle Housing, Ark Housing and Peter McVerry Trust etc. Nine units were delivered in 2023.

Homeless HAP Place Finder

The Homeless HAP Place finder provides assistance in:

- Seeking out potential properties suitable for households currently identified as homeless or at risk of homelessness.
- Liaising with specific households to establish their specific needs.
- Establishing relationships with local property agents and landlords; and,
- Supporting those homeless households to (a) prevent the necessity to enter emergency accommodation or (b) to exit emergency accommodation and secure a tenancy.
- ➤ To date, 536 households (375 families & 154 singles) have been assisted under the Homeless HAP Scheme in Wicklow County Council from the inception on 1st October 2018 to 31st March 2024. (218 homeless cases, 299 prevention cases to date and 18 direct provision). 139 properties were sourced by WCC.

Addressing Homelessness in Partnership with Approved Housing Bodies

Homeless Supported Temporary Accommodation - Kilmantin Hill, Wicklow

Kilmantin Hill has 11 rooms to support persons either homeless, exiting a higher support facility, or in danger of becoming homeless.

There are 9 clients supported in the Kilmantin Hill facility, operated by Dublin Simon. There is continuous transition by the clients to suitable alternative accommodation.

A report is being undertaken at present to cost the refurbishment of the current rooms with a view to making them all ensuite. More details will be available over the coming months.

Homeless Family Service - Fitzwilliam Road, Wicklow

Dublin Simon are engaged by Wicklow County Council to operate and manage the facility at Fitzwilliam Road, Wicklow as a Family Homeless Service. The building comprises of three 1-bed units, two 2-bed units, and two 3-bed units. Eleven families have now transitioned or are in the process of transitioning to a permanent home and the resulting vacancies are in the process of being occupied with families experiencing or in danger of homelessness.

It is envisaged that families will avail of the service for circa 6-months STA (Supported Temporary Accommodation) with key working support to enable families to transition from homelessness into Homeless HAP, or alternative longer-term accommodation.

Homeless Supported Temporary Accommodation - San Remo, Bray

San Remo is operated by Dublin Simon and incorporates a service model whereby there are a number of emergency/cold weather initiative beds and Supported Temporary Accommodation Beds (STA). There is on site key working support linking in with clients.

CWI (Cold Weather Initiative) beds are currently in operation in San Remo and will continue until April 2024.

The Neighbourhood Liaison Committee is now operational and meets monthly.

Bi-monthly meetings are held with Dublin Simon and Wicklow County Council staff.

Homeless Supported Accommodation - Carraig Eden, Greystones

This facility provides 35 ensuite bedrooms with associated kitchens and common areas and is fully operational. Wicklow County Council run an in-reach service with the clients to support them as they continue their journey into more permanent accommodation.

Other Homeless Supported Accommodation

Wicklow County Council owned properties in Wicklow, Bray, and Greystones, leased to Approved Housing Bodies, provide 12 units of low to medium supported accommodation targeted to the particular support needs of the clients. Six of these persons living in shared accommodation have now successfully moved into their forever homes and this in turn created space to move further people out of homelessness.

A homeless outreach service has been rolled out in Bray and is proving very successful.

Housing First

Peter McVerry Trust has been appointed as the Housing First Programme Implementer for the Mid-East Region. Wicklow County Council is committed to working with them and has now reached and surpassed the targets identified in the programme. Housing First recognises that a stable home provides the basis for recovery in other areas.

Properties will be provided by both Wicklow County Council and Peter McVerry Trust for the implementation of the programme.

Wicklow County Council has, to date, successfully accommodated 18 clients under Housing First. Other clients proposed for Housing First have been assessed by the team and are availing of key support work pending finalisation of sourcing of accommodation. The main issue facing this programme is the availability of 1-bed units in suitable locations with easy access to required services.

Homeless Action Plan 2024 - 2026

The plan was approved by the elected members of Wicklow County Council at the Council meeting on 8th April 2024.

Youth Homeless Strategy 2023-2025

- Three-year strategy published 9th November 2022
- Focus on ending homelessness for young people aged 18-24 through:
 - Prevention of young people from entering homelessness
 - Improving the experience for young people accessing emergency accommodation
 - To assist young people exiting homelessness
- Multitude of stakeholders all with vital roles in addressing fundamental issues

<u>Ukrainian Response</u>

As of 18th April 2024, the number of Ukrainian Displaced Persons in emergency type accommodation is 1,803 (although we know that there are considerably more in the County)

This number is broken down as follows -

Wicklow County Council are currently assessing all Displaced Ukrainians persons in the County in order to identify their accommodation needs, as well linking them in with all the relevant services and supports within the community.

Wicklow County Council are working through a list of pledged properties within the County and matching families accordingly. As of 18th April, Wicklow County Council will have housed 262 displaced Ukrainian people into pledged stand-alone 'Offer a Home' properties with the County.

Larger buildings and vacant units are also being identified and explored as potential options for medium to long term accommodation.

The Community Response Forum continues to meet on a regular basis.

Community Recognition Fund 2024

The Minister for Rural & Community Development, Heather Humphreys TD, together with her colleague Minister Joe O'Brien TD, have announced a further €50 million in national funding under the Community Recognition Fund to deliver projects over 2025 and 2026.

The Community Recognition Fund was first introduced last year to recognise the huge efforts made by communities in welcoming and supporting people coming to Ireland.

Wicklow County Council has been allocated €1,584,550 under the 2024 Community Recognition Fund.

The Community Recognition Fund 2024 aims to support the development of community infrastructure and facilities for the entire community, in recognition of the contribution being made by communities across the country in welcoming and hosting significant numbers of arrivals from Ukraine and other countries.

The scheme details set out that only areas which have high levels of new arrivals will be deemed eligible for this scheme.

Wicklow County Council is seeking expressions of interest for project proposals from community groups in areas where large numbers of citizens from other countries are currently living. Projects to be funded will be capital in nature, deliver medium to long term benefits for the communities in which they are located, and be capable of being delivered over the course of 2025 to 2026. The application window is now open for submissions. Applications will be accepted until 4pm on Friday, 10th May 2024.

An information session was held online on 18th April 2024 at 5.30pm, with approximately 35 groups joining this online session.

Community Awards Scheme 2024

As part of its commitment to supporting local community development, Wicklow County Council operates an annual Community Award Scheme. The fund for 2024 will be available as grant aid to successful community groups and local organisations wishing to undertake community projects in their area. There is a maximum grant amount of €500 per organisation for small projects and group running costs. Only one application per group will be considered. The Community Awards Scheme 2024 closed for applications on Friday 26th April. Assessment of applications is underway.

Local Enhancement Programme 2024

The Local Enhancement Programme for 2024 closed for applications on 8th March 2024. The scheme was announced by Minister for Rural and Community Development and Minister of State with Responsibility for Community Development and Charities on the 6th of December 2023. €176,338.11 was allocated to Wicklow County Council, €29,389.69 of which has been reserved for Women's groups in recognition of the fact that there is a growing number of Women's Sheds, Groups, and Networks across the country.

This funding will provide capital supports essential for the many small community groups and organisations, particularly those who serve disadvantaged areas in rural and urban areas. There will be a particular focus on small capital works/improvements, and the purchase of equipment for community use.

Wicklow Local Community Development Committee (LCDC) is responsible for allocating funding for this scheme. Applications should relate to one or more key priority areas identified in their LCDC's Local Economic and Community Plan (LECP) in order to be eligible for consideration.

The assessment process was completed and approved by the Wicklow LCDC on Wednesday 10th April and returned to the Department for final approval. Once approved, applicants will be notified directly, and arrangements made to pay the successful applicants in accordance with the terms of the scheme.

Fáilte Ireland Regional Grants Scheme 2024

Wicklow County Council was approved for the sum of €13,000.00 in respect of the Regional Festival and Participative Events Funding 2024.

The Regional Festival and Participative Events Programme is aimed at festivals and participative events that fit into one of the following categories:

- General festivals (i.e. literary, historic, traditional culture or family focused)
- Arts, Music & Theatre
- Food & Drink
- Sports & Outdoors
- Business & Education

Wicklow County Council has discretion as to how and to whom it wishes to allocate funding for 2024. It is the Council's remit to ensure that these funds are spent on those festivals and participative events that best drive tourism and have an economic impact.

Following consultation with Wicklow County Tourism and County Wicklow Arts Office, five festivals and participative events were recommended for funding in 2024. Payments have been processed to the following:

Joint Policing Committee Public Meeting

Wicklow County Council Joint Policing committee held a public meeting on Tuesday 23rd April 2024 at The Avon, Burgage More, Blessington.

The purpose of the JPC is to provide a forum where the local authority and the senior Garda officers, responsible for the policing of that area, can consult and make recommendations on matters affecting the policing of the area and in particular to keep under review the levels and patterns of crime,

disorder and anti-social behaviour occurring and the factors underlying and contributing to it. Membership of the committee consists of the Chief Superintendent, Senior Members of the Gardai, Wicklow County Council Chief Executive, Elected Members and representatives from the voluntary and community sector.

Councillor Gerry Walsh, Chair of the Wicklow Joint Policing Committee, welcomed and thanked all present for taking the time to attend the meeting and for their engagement during a lengthy questions and answers session. The issues raised were met comprehensive responses from both Chief Superintendent Derek Hughes and Superintendent Rory Sheriff.

Superintendent Sheriff delivered a presentation outlining the new operating model in the Wexford/Wicklow division, which was implemented in March 2024, along with detailed statistics on crime trends for the Blessington area. Chief Superintendent Derek Hughes gave a presentation which demonstrated crime data for Wicklow division and set out the plans for Q2 2024.

Emer O'Gorman, Chief Executive, thanked everyone for their attendance and engagement, and noted that public JPC meetings are an excellent example of community, Gardaí and the Council working together through a collective approach to the benefit of all members of our local communities.

Action 3.8 Appoint Healthy Age Friendly Homes Co-ordinator & Rollout Wicklow Programme

Healthy Age Friendly Homes (HAFH) Programme is a support coordination programme that aims to enable older people to age in place and reduce the need to transfer to long-term residential care. The Programme is a collaboration between the Department of Health and the Department of Housing and Local Government. It is funded by the Department of Health and operated by Meath County Council, on behalf of all Local Authorities.

The service is designed to enable older people to remain living in their own home for longer. The local coordinator undertakes home visits to older people living in the community, where a needs assessment is carried out, looking at four key areas of supports: housing, health, community/social supports, and technology. Home visits from the local co-coordinator are available to anyone aged 65+years. **Marion Van der Wel** has been appointed as **Local Coordinator** for County Wicklow.

The programme's ambition is based on four key objectives:

- 1. Enable older people to continue to live in their homes, or in a home more suited to their needs
- 2. Live with a sense of independence and autonomy
- 3. Feel part of, and be part of, their community
- 4. Support the avoidance of early or premature admission to long-term residential care

The programme accepts referrals from a variety of sources including from:

- The older person themselves
- Family and friends
- Elected Representatives
- Local Authority Staff

- Public Health Nurses, GP's and Occupational Therapists
- Community Organisations



Please note, consent from the older person (verbal) must be obtained before the referral is submitted. Once the referral is received, Marion will be in-touch with the older person to arrange a free home visit.

Healthy Wicklow

County Wicklow Food Coordinator

Under the key performance indicator, a decrease in the percentage of those at risk of poverty and basic deprivation a County Wicklow Food Coordinator position has been approved under the Healthy Ireland Fund Round 4. Bray Area Partnership has been awarded the hosting agency for this position. Interviews took place on Monday 8th April.



Brain Grooves Hip Hop (7+) Rathnew

Brain Grooves is a programme of dance lessons created by tutor Zoe Patterson designed to engage the bodies and minds of students. This 6-week programme commenced on 8th April and had maximum capacity targeting age cohort 7+. What makes this programme different from regular dance lessons is that it combines brain activation with body movement.

Boxercise Programme

A new dynamic 6- week boxing and exercise programme started on 12th April in Gaelscoil Chill Mhantáin Rathnew. Boxercise is for everyone, regardless of age, fitness level, or experience. This course was fully booked out.

Dancing with Declan Programme

Learn to dance the easy way is commencing in Tinahely Community Hall on 26th April. Not only does this programme promote physical fitness and well-being, but also fosters social cohesion and self confidence among participants from the Tinahely/Shillelagh/Carnew area and its environs.

Period Poverty Project

Due to the success and demand for the period poverty initiative across Wicklow an expression of interest was submitted to the Department of Health for further funding for 2024. Wicklow has received approval for an allocation of €15,000 to continue the roll out across disadvantaged communities.



Local Authority Integration Team

Process Updates

The LAIT is in place since January 2024. During the establishment phase, the team focused on networking across a wide range of statutory and community stakeholders, including the IPAS centre managers. The Wicklow LAIT has developed a prioritisation process in order to target the individuals and families in most need of support in Wicklow as follows:

- New International Protection Applicants arriving to new centres: These will be identified as per communications from the LGMA and DECIDY. For the most part, LAIT support for these groups will consist of Advice and Information clinics and coordinated engagement with additional support providers.
- New International Protection Applicants arriving to established centres: These will be identified locally through a weekly communication process with IPAS centre managers. When identified, the LAIT will conduct an initial 1:1 support session, and the clients will be able to access follow up support at any Advice and Information Clinics held at their centre.



- Residents in established centres: The team will conduct regular Advice and Information clinics
 across a range of IPAS centres in Wicklow, with a particular focus on centres where support, or
 access to support, is limited.
- 4. <u>Centres and/or individual clients requesting support</u>: the LAIT can be contacted directly at integration@wicklowcoco.ie.

As such, and based on the range of needs identified so far, there will be three forms of engagement with clients by the Wicklow LAIT as follows:

- 1. Advice and Information clinics
- 2. 1:1 appointment-based meetings with targeted clients.
- 3. Themed workshops and information sessions (e.g. a training and education session, possibly conducted in collaboration with appropriate stakeholders)

Client engagements

Advice and Information clinics

By the end of April, the LAIT conducted 7 Advice and Information Clinics in IPAS centres. At the time of writing this report, the average time of engagement per client is 40 minutes. The majority of those accessing the A&I clinics are International Protection Applicants, however a smaller number of people with status have requested support regarding employment and housing applications. The predominant requests are for support accessing employment, training, and health services. The team have assisted clients to complete work permit applications, apply for training and education, signposted to a range of community support services, arranged medical cards, and made referrals to HSE Social Inclusion for several clients with significant health concerns.

Targeted 1:1 with new arrivals

As a result of collaborating with the IPAS centre managers, the team have been able to target newly arriving families to existing centres, providing them with initial integration supports including orientation to their local area, support accessing school places, medical card applications, MyGov ID registration, and referral to HSE for medical assessment.

The **Directory of Services** for all services offering supports to new communities in Wicklow is complete.

Social Inclusion Community Activation Programme (SICAP):

Bray Area Partnership and Co. Wicklow Partnership presented their Annual Plans 2024 to the most recent meeting of Wicklow LCDC. As both demonstrated a comprehensive range of work in supporting the needs of SICAP target groups and were also in compliance with all technical and budgetary requirements as set out by Pobal, both Plans were formally approved by the Committee.

Co. Wicklow Public Participation Network (PPN):

Membership: Currently 445 members in total. 22 new community groups joined since start of year.



Informative and effective environmental networking event held between Wicklow County Council Climate Action Team, PPN member groups and An Tairseach Farm & Ecology Centre.

Consultations: Wicklow Coast Blueway Project; Arklow Local Area Plan; Blessington Local Area Plan Pre-Draft; Part 8- M11 Junction 19 Weighbridge Facility; N81 Hollywood Rural Traffic Calming.

Variation No 2 to the County Development Plan 2022 – 2028 (Wicklow Town - Rathnew LAP)

We are currently preparing proposed Variation No. 2 to the WCDP 2022-2028. The purpose of the Variation will be to ensure consistency between the WCDP 2022-2028 and the draft and final Wicklow Town — Rathnew Local Area Plan, which is being prepared separately but alongside the Proposed Variation. Consultants have been appointed to carry out the SEA and AA for the Variation and the initial stages of the SEA screening is currently being carried out.

Local Area Plans

There are 5 Local Area Plans in Wicklow for the following settlements – 'Bray Municipal District', 'Wicklow Town - Rathnew', 'Greystones – Delgany & Kilcoole', 'Arklow & Environs' and 'Blessington'. We are currently reviewing all five.

Wicklow Town - Rathnew Local Area Plan

Pre-draft consultation closed for the new Wicklow Town - Rathnew Local Area Plan closed on 28 September 2023 with 84 submissions received. A well-attended public information day was held on 14 September 2023. All valid submissions have been reviewed and considered and a draft plan is being prepared. Once



the draft plan is prepared it will go out on public consultation for 6 weeks with submissions invited from everyone. It is hoped that the draft plan will commence display in Q2 2024.

Consultants have been appointed to carry out the SEA and AA for the LAP and they are continuing to work on the SEA/ AA work. Residential Zoned Land Tax (RZLT)

The Government's Housing For All – A New Housing Plan for Ireland has introduced a new tax to activate vacant land for residential purposes as a part of the 'Pathway to Increasing New Housing Supply'. The draft RZLT maps for lands liable in 2025 were published on 01 February 2024. Submissions were invited on the draft maps up to 01 April 2024 with 9 submissions received. Vacant Site Levy

This programme is still ongoing and is affected by the proposed deferral of the RZLT. As liability to the RZLT is now proposed to be deferred for one year, it is considered appropriate to maintain provisions in legislation for the management and continued charging of the vacant site levy in respect of land which is identified on the register. This will continue to facilitate imminent placements on the register, conclusion of appeals and to facilitate the issuing of demands in relation to the levy for the period to the end of 2024. This will ensure that the use of the levy as an active land management measure will continue until the RZLT is in effect.

Heritage Office

County Heritage Plan (CHP): The Heritage Council have approved a funding allocation of €57,000 for projects submitted under the following thematic areas; Landscape People & Place; Wicklow Community Archaeology Projects: Heritage Recording & Surveying; Consultation and Planning. The part time Wicklow Community Archaeology service has been funded for a third year.

Wicklow Heritage Forum Meeting: Next meeting is scheduled for 30th April.

Irish Community Archive Network (iCAN) – Five new community groups have signed up to the *Our* Wicklow Heritage network and are currently receiving training in setting up their digital archives. The Groups are Roundwood Historical Society & Friends of Derralossary; Blessington Heritage Group, Wicklow Film Archive; Tinahely Past Heritage Group.

Archaeology: Community Monuments Fund- CMF 2024. Six projects have been a successful in receiving funding allocations as per project applications prepared by the Heritage Office and submitted to National Monuments Service. These are: Drumgoff Barracks €12,159 for structural repairs plus €29,889 for Conservation assessments; Mullinacuff Church €90,678 for repair to medieval masonry; Kilmacanouge (Old) Church €30,000; St. Kevin Church Hollywood €29932 for conservation plans, and €9,588 for Kilranelagh Graveyard survey

Built Heritage Capital Funds (Architecture): A funding allocation of €101,000 has been received in respect of 16 projects shortlisted for County Wicklow under the Built Heritage Investment Scheme (BHIS). There are 4 projects which have been successful under the Historic Structures Fund (HSF) as follows;



Coolattin House €171,000; Clermont House €171,000; Former Post Office, Shillelagh €20,000 and Vernacular house at Rosebank, Avoca €10,000.

to long term grassland/scrub habitat: establishment and operation of a construction and demolition waste recovery facility; installation and operation of a soil washing plant and all associates site works at Ballinclare and Carrigmore townlands, Kilbride, Co. Wicklow – Decision, refuse permission under section 37G of the Planning and Development Act 2000, as amended, 27/09/2023.

Lands at Ballinabarney North & Bolagh Lower, Redcorss, Co. Wicklow.

E-Planning Project.

The ePlanning system went live on 17th April 2024 and from that date to 31st December 2024, 50.62% of planning applications were received online.

For the month of March 2024, a total of 132 planning applications were received of which 46.21% were hard copy applications and **53.79% were received online**.

From 1st January 2024 to 31st March 2024 a total of 341 applications were received of which 45.16% were hard copy applications and **54.84% were online applications**.

Due to the complexities of larger applications, it has been necessary to request one hard copy for larger multi-unit developments.

Economic and Rural Development

Town Regeneration

Blessington Town Centre First Masterplan

Blessington is a pathfinder town and is the first to receive funding for a Town Centre First Masterplan. The masterplan will provide Blessington with a clear framework to positively develop the town now and into the future. The implementation of the TCF plan is at the planning stage. RRDF funding will fund the redesign of the Main Street and Market Square and bring those projects to a shovel ready stage where they can be submitted for funding for Category 1 RRDF.

Newtownmountkennedy has been announced under Phase 2 as one of the next 26 towns approved to develop Town Centre First Plans. Funding support of €30,000.00 will be given to each of these 26 towns to help with completion of a comprehensive town plan. Further funding of €10,000.00 is being given to Local Authorities to establish three new town teams or to build up existing teams. An application has been forwarded to the Department on 6th March 2024 for Baltinglass, Rathdrum, Kilcoole and Shillelagh.



Funding Schemes

Town Centre First – Suite of Supports

Newtownmountkennedy have recently been approved for funding of €30,000.00 under Town Centre First Measure 2 Suite of Supports. This Town Centre First Plan must be completed, and reports submitted to the Department by 5th September 2025.

The Town Centre First Measure 3 Application closed on the 8th April.

Two applications have been submitted for this project funding:

- Blessington measures to include enhancement to the Square with tree planting and a rain garden, spaces for dining and fixed seating.
- 2. Wicklow Town Further enhancement at the Black Castle area to encourage more tourism and attractions for locals with installation of picnic tables, seating and a sculpture park.

Thrive

Under the new Thrive – Town Centre First Heritage Revival Scheme Strand 1, two applications were submitted on the 5th April for Bray and Wicklow Town/Rathnew. The aim of these projects is to enhance and develop existing Town Realms under the Town Centre First approach.

The Town Centre First Heritage Revival Strand 2 for Bray Courthouse and Heritage Centre is presently being discussed and an architect has been appointed to help in the preparation of the application which is due to be submitted on the 3rd May.

Town Teams

We currently have four Town Teams: Arklow, Wicklow, Greystones and Blessington. Discussions are continuing on the future establishment of a Bray Town Team.

The teams work closely with the Town Regeneration Office, attending meetings and giving information on funding and grants available to Town Teams.

Rural and Urban Regeneration Development Fund Grant Applications

Steering Group for the Progression of URDF and RRDF Projects

The Chief Executive has established an interdisciplinary team for the progression of Wicklow County Councils URDF (Urban Regeneration and Development Fund) and RRDF (Rural Regeneration and



Development Fund) projects. The group meet monthly to streamline the advancement of RRDF and URDF projects along with a sub-group that will meet fortnightly and report to the steering group. This is a significant step in setting up the structures for town regeneration in the County.

These groups continue to meet fortnightly and monthly for discussions on updates.

Blessington RRDF: Blessington has been awarded over €1m funding under the Rural Regeneration Development Fund (RRDF) to be used for the regeneration of Blessington Town Centre, the development of plans for public realm works, the redevelopment of a vacant/derelict property to create an eHub and a Visitor Centre for the forthcoming Blessington Lakes Greenway.

Baltinglass RRDF: The costing for Baltinglass Gateway to Southwest Wicklow has come in over budget on both the public realm and the Courthouse refurbishment. The proposals have been revised and the necessary technical plans are complete in order for the works to commence. Works on the Public Park and playground are underway.

Application for further funding on this project was made to the Department on the 7th February 2024.

Newtownmountkennedy RRDF: The project is under review at present due to revisions necessary to the public realm, due to contested issues regarding the design of the public realm. Following the necessary revisions, it is hoped that agreement will be reached, the plans will be signed off and submitted for Category 1 funding.

URDF: Urban Regeneration Development Fund

URDF Call 3: The URDF announced recently that Wicklow will receive €2.5 million to assist long term vacancy and dereliction. Four properties have been chosen (two in Arklow and two in Wicklow) and the process has commenced in acquiring these properties. An information gathering notice has been published on a number of the properties seeking information to be directed to the Council.

Another property has been identified in Arklow and we are now awaiting approval from the department to start the process of acquiring this property.

Bray Harbour Improvements: A tender will be issued when the URDF funding has been confirmed for the next phase of the project. A business case has been sent to DHL&H and a tender brief is being prepared for the procurement of engineering consultancy services to produce detailed designs, environmental reports and an application to An Bord Pleanala for the proposed works.



Tourism

Wicklow County Council Tourism Office continues to promote County Wicklow as a destination not only to domestic visitors but also on the international market using a range of tools and activities including:

Promotion: Wicklow Gardens, Wicklow Music Festivals & Wicklow Outdoors: This month, the promotion activities were based around spring and the reopening of the various Wicklow Gardens. Focus was also given to Wicklow's two major music festivals, West Wicklow Chamber Music Festival, and the Bray Jazz Festival. Features also covered the first Wicklow Mountain Bike Festival which will be held at Ballinastoe over the May bank holiday and the very popular Hell & Back event.

Irish Wish Movie: Irish Wish, the Netflix movie starring Lindsey Lohan, has generated extensive interest around the various Wicklow film locations which were featured in the movie.

Wicklow Passport Interactive Map and New Stamps: The new interactive digital map is making it much easier for visitors to find the nearest stamping locations. Another feature on the map includes a pop up window showing the stamps design available at each location. This feature is becoming very handy as members are encouraged to design and use their own stamps. New stamps include a dedicated design for Wicklow Gardens with the first one available at the Botanic Gardens at Kilmacurragh.

Meitheal - Killarney

The annual event is Fáilte Ireland's flagship trade event, which is organised in conjunction with Tourism Ireland and enables Irish tourism businesses to sell the best of Ireland to top international tourism buyers. Wicklow County Council was present to offer support to the Wicklow tourism trade present at the event as well as engaging with representatives of Failte Ireland and Tourism Ireland.

Local Government Tourism Conference – Kildare

The conference provided a great opportunity to bring the sector and key stakeholders together to hear from a range of engaging speakers, share knowledge and ideas and to look to the future of tourism in Ireland. This year's special focus was given on Sustainable Tourism & Destination Development, Innovation in Tourism, Re-imagining Local Tourism, EU Just Transition for Tourism, and Global Irish & The Power of Networks.

Abbey Grounds, Wicklow

A detailed design of the Abbey Grounds has been completed to date. The Architect and Structural engineers are almost complete on the tender drawings and tender package for the Coach House refurbishment. A tender request for the refurbishment of the coach house has been published on eTenders with a closing date of 5th April 2024.



The detailed designs for the Amphitheatre and Park area are being finalised. These works will be issued as a separate contract due to the nature of the works. A proposal for the lighting design for the Amphitheatre and Park area has also been commissioned.

The tender for the coach house refurbishment works closed on 5th April. The assessment of the tender responses will be progressed as quickly as possible with an appointment of a contractor by mid to end May 2024 (for coach house refurbishment only).

Glendalough Masterplan and Wicklow Visitor Orientation Study

Following on from the launch of the Glendalough and Wicklow Mountains National Park Visitor Experience and Management Masterplan, work has begun on the implementation of the Plan. A Steering Group has been established, which is chaired by the Chief Executive of Wicklow County Council.

A Working Group comprising representatives from all stakeholders has also been formed and has commenced work on short term actions for 2024, along with longer term actions also. As community consultation and participation is a central tenet of the masterplan, a Local Advisory Group will be established to keep the local community informed and ensure their input to the process. Individuals and groups with a focus on the community have been invited to join the Local Advisory Group. The first meeting of the group is taking place on 9th May 2024 at the Brockagh Centre.

Special Projects

Greystones Enterprise Hub: Property Management Contracts have been signed between Greystones Enterprise Hub CLG and Cushman and Wakefield for the fit-out, marketing, and management of the centre. A Concept Proposal for funding has been submitted to Enterprise Ireland under the Smart Regions Enterprise Innovation Fund. Wicklow County Council is meeting with Cushman and Wakefield and with Enterprise Ireland in April to discuss progress on these.

Sites on Mill Road, Greystones: Progress on the Mill Road sites is on hold pending PRA confirmation of site registration.

Carnew Remote Working Hub: Contracts have been signed for the design of the former Bank of Ireland building in Carnew for the provision of a remote working hub and ancillary facilities. A timeframe of 12 months has been given for design, costing (to include estimate construction costs and fit-out costs), and Part VIII if required.

Marketing Plan: MarketingCoach were awarded the contract to develop a Marketing Plan for County Wicklow, highlighting the availability of Remote Working Hubs and Broadband Connection Points. A



Marketing Plan has been agreed recommending a campaign idea "Choose Wicklow". Requests for quotations have issued seeking the provision of consultancy services to support the implementation of the plan.

Offshore Renewable Energy

The Offshore Renewable Energy (ORE) Network continues to meet regularly and engage with the offshore renewable energy companies who are developing proposals off the coast of County Wicklow. A plan for 2024 based around three work-streams (skills, ports/harbours, and supply chain) has been agreed.

Skills Strategy

The Draft Skills Strategy for County Wicklow is under final review. It is expected to launch in Q2 of 2024. The Skills Taskforce continues to be central to the preparation of the draft plan. Once launched, the work of the Taskforce will turn to implementing the plan.

Food and Beverage Strategy

Wicklow Naturally - The 2024 Wicklow Naturally Action Plan to achieve objectives set out in the Wicklow Food and Beverage Strategy has been prepared and agreed by the board.

Interviews to appoint a coordinator for Wicklow Naturally have taken place and work is underway to appoint the successful applicant.

Wicklow County Council has been awarded grant funding from the Department of Agriculture, Food and the Marine to support Destination Wicklow, a project focusing on telling the story of Wicklow Naturally members and their products. Preparation work on this project has commenced.

Avoca Mines Remediation Project

The Council is working in Partnership with DECC to advance the Remediation of the Avoca Mines project. Currently, this work primarily involves making the mines sites safe, by replacing fencing and making safe access to locations that require sampling and monitoring. The contract has been awarded to complete the fencing around Cronebane and Tigroney sections of the Mines. Monitoring and repair works to existing fencing continues.



Arklow Flood Relief Scheme

These appointments are Online and library staff will help to connect with the Information Officer on the computer in a private space, to guide you with information and advice on rights and entitlements.





The Movie Club (Adults)is due for a relaunch in April and plans to have one showing each month, offering an enjoyable experience for adults. Due to licencing agreement, to discover the film schedule, it is necessary to drop into the library.







Blessington Library

Easter was celebrated at Blessington Library with a variety of engaging activities aimed at fostering community engagement and promoting literacy among children. A highlight was a creative writing workshop led by bestselling Children's author Caroline Busher, catering to children aged 9-12. Eighteen children participated in the workshop, where they explored their imaginations, honed their writing skills, and let loose their storytelling potential.

Additionally, two movie sessions were hosted, one for all children and another specifically for those aged 12 and above. These film screenings provided opportunities for community members to come together, socialise, and connect in a relaxed and informal setting.

Blessington Library has organised a series of activities in line with the "Spring into Story Time at your library" initiative. Throughout April, regular Saturday morning Stories sessions are tailored to promote Spring into Story Time. Library staff engaged children with lively readings, interactive discussions, and creative activities related to the stories. A special day for babies and toddlers, led by Rachel Drew from Let's Sing, took place on Thursday, April 11th, featuring music and song workshops. On Friday, April 26th, a special tea story time for children ages 4 will be hosted. This event combined the joy of storytelling with the cosy atmosphere of a tea party, with library staff reading "The Tiger Who Came to Tea" by Judith Kerr.

In addition to storytelling, two craft workshops were organized. The first, a Clay workshop, engaged children aged 7 and above in a hands-on activity to create clay magnets. The second held on April 19th as part of Earth Day, introduced children to the concept of sustainable development and the Sustainable Development Goals (SDGs) through a Creative Craft session using recyclable materials.

Children from the Fun Bugs crèche were eagerly welcomed for a fun and educational morning at the library (day to be confirmed in April). Additionally, on April 8th, a special visit was received from the Autistic Unit at Lacken School.

Recurring events, including adult and children book clubs, poetry and writing groups, continue to play a vital role in fostering community engagement, promoting literacy, and enriching the cultural fabric of the library.





Bray Library

April brings a quieter vibe to Bray Library as students focus on their exams. But that doesn't mean the library is empty! There's plenty happening. Storytime sessions took on a spring theme especially for the annual celebration of reading to children, Spring Into Storytime with every Monday morning featuring nature stories for little ones, while Tuesdays featured outdoor adventures for older kids.

Rathdrum Library



Archives & Genealogy Service

Successful funding application

The Archive Service has been granted funding under the Heritage Council's Heritage Stewardship grants scheme 2024. The project is on the *Tate Charity Trust* collection (1787-1990): To produce a descriptive catalogue, exhibition and online resources. In 1787 John Tate of Glenmalure bequeathed his lands of 895 acres to the parishioners of Rathdrum. Tate vested the property into the hands of five named Trustees and they along with their successors administered the Charity known as *John Tate's Charity*, with the capital gained from this estate down through the years of its existence up to the present day. This project will enable us to make accessible to researchers this incredible collection both through a descriptive list and also through interpretation in terms of the exhibition and articles, promoting to as wide an audience as possible.

Decade of Centenaries

A new young persons' publication *Wicklow Gaol: Three Centuries of Incredible Irish History* has been developed as part of Wicklow County Council's *Decade of Centenaries* programme, supported by the Department of Tourism, Culture, Arts, Gaeltacht, Sport & Media. The book has been distributed to all Wicklow library branches and each County Wicklow primary school has received a classroom set both in English agus as Gaelige. The author Carmel Ui Cheallaigh and illustrator Jimmy Burns have presented workshops in the libraries of each MD, with more to follow due to popular demand.

Collections management

Installation of cataloguing software *Axiell Collections*. The County Wicklow Archivist continues cataloguing the County Wicklow collections using the new software and each collection listed will be published to Wicklow.ie.

New collections

APRIL 2024



The estate papers of the Actons of Kilmacurragh dating from the 1660s. The Actons acquired the Kilmacurragh estate during the 17th century and developed the famous arboretum in the 19th century, now operated by the OPW. In 2021 the OPW announced funding of €5.45 million for structural work at Kilmacurragh House. A catalogue for this collection is now completed, in preparation for an exhibition to coincide with the refurbishment of Kilmacurragh House.

Outreach

Special projects

Arklow Street Preachers project based on our glass plate negatives collection of late 19th century images of these events in Arklow. Phase one completed – digitisation of the images. Phase two ongoing - collaboration with historian Pat Power and the Arklow Maritime Museum on a publication and exhibition. Editor appointed.

Education programme

County Archives resources developed for the Leaving Cert History Research Study Report are available on the www.wicklow.ie website. School visits by the County Archives to continue.

Mother and Baby Institutions Payment Scheme Act 2023

Wicklow County Archives is developing a protocol with the Department of Children around records research and accessing records to provide the Department with documentary evidence for claimants to the scheme, in relation to time spent in the Wicklow County Home. Scheme commenced in March 2024.

Recreation

Coastal Blueway

Following meetings with Irish Leisure Consultants (ILC), we are developing a timeline for the project over the next few months, with consultations taking place in Greystones and Arklow on the 13th and 14th March aimed at sport providers, clubs and tourism businesses.

The Blueway project is moving towards the second stage of the accreditation process with the current accreditation mainly reliant on provider-based activities. We are liaising with the Blueway Partnership to identify where self-led Blueway trails might be located.

Wicklow Outdoor Recreation Committee (WORC)

The next WORC meeting will take place on the 25th of April 2024 at Coillte Headquarters in Newtown Mount Kennedy, to continue the delivery and progress of the County Wicklow Outdoor Recreation Strategy 2020- 2025.

Wicklow Way Partnership

Following the Wicklow Way Partnership meeting on the 6th February 2024, a MOU was signed by all parties and updates were given on the new Wicklow Way logo and a formal maintenance structure for the trail. WWP partners are: Wicklow Co Co, Coillte, Mountain Meitheal, County Wicklow Partnership, National Parks and Wildlife Service and Dublin Mountains Partnership.



Outdoor Recreation Infrastructure Scheme

The Outdoor Recreation Infrastructure Scheme (ORIS) supports the development of new outdoor recreational infrastructure and the necessary repair, enhancement, or promotion of existing outdoor recreation infrastructure in countryside areas across Ireland. The Scheme is funded under "Our Rural Future" which specifically prioritises the growing outdoor activity tourism sector as part of a long-term vision for a vibrant and sustainable rural Ireland.

There are two large Measure 3 projects which will commence in 2024:

Roundwood Recreation Area - It is envisaged that these works will commence in quarter 2 of 2024.

<u>The Sugarloaf Repair Scheme</u> – Part VIII CE Report submitted to CE and will be presented to the members of Bray Municipal District in April.

Lugnaquilla Recreation Plan

Quotation requests were sought from six companies based in Co Wicklow to provide a Feasibility study into management of Recreation on Lugnaquilla. From this tender process, 2 companies were unable to quote at present, 2 were unanswered and one of them has returned a full quotation, Go Wild Ltd, based in Ashford, Co Wicklow.

Bray Head Sustainable Recreation Plan

This project development measure will set the requirements for the Measure 3 project to be funded and expected to be completed in 5 phases in 2025.

2023 ORIS Projects announced

On Thursday 28th March, Minister for Rural and Community Development, Heather Humphreys TD, announced funding of €4.1 million to develop and enhance over 150 outdoor recreation projects around Ireland.

In Wicklow, 6 projects with total funding of €174,780 have been approved for Wicklow County Council to implement around the County. This funding is in addition to the €90,000 which was announced in November 2023 for 2 projects under ORIS Project Development Measure. Two further projects, under Measure 1, have also been approved for County Wicklow Partnership for €52,725.

This will be delivered in conjunction with the Wicklow Drugs and Alcohol taskforce and Wicklow sports clubs.

Chronic Condition Programmes - HSE Seed Funding

Strength & Balance Programme

Due to waiting list popularity term two of our Strength & Balance Programme started Tuesday April 9th in Shoreline Leisure Greystones. The programme is aimed at people who are prone to falling and struggle with balance and mobility. Again, the programme is full, with a waiting list. Each participant has been given a Wicklow LSP drawstring bag consisting of a pen and a HSE Falls Prevention Booklet.

Aqua Aerobics for People with Chronic Pain & Arthritis

Due to waiting list popularity, term two of our Aqua Aerobic for People with Chronic Pain & Arthritis starting 22nd of April. The programme is aimed at people with chronic pain such as: arthritis or back pain. This programme is taking place on Monday's at 12pm in Shoreline Leisure, Bray with a staff member delivering. The programme is full with 16 people registered and with a wide range of chronic conditions being targeted.

Aqua Aerobics for people with Parkinson's

A six-week programme with nine participants taking part each week. This programme is taking place in Druids Glen, as there are steps down to the pool, a handrail and the pool is one depth. Overall feedback has been very positive, with participants finding huge benefits to their health.

Tai Chi for Asthmatics

This is an 8-week programme which started Tuesday 09th April in Shoreline Leisure, Bray. 16 people are taking part and Patricia Cronnelly is our Tai Chi teacher.

Walk & Talk Bray

A 10-week programme aimed at people with asthma, COPD and other illness. Taking place in Bray, meeting point at the bandstand on Bray Promenade, twice a week, Wednesday, and Friday mornings. The programme is full with 16 people registered. Lisa Redmond our walking leader will be delivering the 10-week programme.

HSE Grant Aid Agreement Funding

HSE In-Patient Physical Activity Programme

An 8-week physical activity programme in conjunction with OT Aisling O'Sullivan in the HSE in Arklow. This programme took participants through the gym equipment in Coral Leisure Arklow showing them how to use the equipment.

Walk & Talk with Activator Poles

A 6-week walking programme with Aughrim Active Retirement Group. 10 women took part in this programme with purchasing 10 sets of poles.

Siel Bleu Activity Programme for Roundwood Men's Shed

A 10-week physical activity programme starting 23rd April with Roundwood Men's Shed. There are 12 men registered for this programme.



Age & Opportunity Funding

Walking Football for 55+

A five-week Walking Football Programme for people aged 55+. Started Wednesday 21st February in Wicklow Rovers FC. This was a pilot programme being delivered by a walking football leader Peter MacNulty for Age & Opportunity. The programme is now complete, the club have received five footballs, bibs, and a whistle for the programme to continue. There are currently 16 men taking part weekly.

Orienteering teacher training

Wicklow Sports and Recreation Partnership collaborated with Orienteering Ireland to deliver teacher training in East Glendalough School in Wicklow Town. 21 teachers from Primary and Secondary School across County Wicklow attended and gained the Ready to go orienteering qualification. Noise Action Plan

The Dublin Agglomeration Noise Action Plan (NAP) has been put out for public consultation by DCC (as the lead authority). This plan includes the majority of Bray Town.

The Wicklow Noise Action Plan is currently being drafted.

M11N11 Junction 4 to 14 Improvement Scheme

The Option Selection report was published along with Bulletin #11 on the project website www.n11m11.ie on 14 December 2021. The publication followed the review of submissions received during public display in 2021. Phase 3 Design and Environmental Evaluation was due to commence in Q1 2022. The scheme is currently suspended as no funding is provided. The Wicklow County Council project team are continuing to meet with the public and any interested parties.

M11N11 Bus Priority Interim Scheme

The BPIS seeks to achieve the early delivery of bus priority measures in advance of the main scheme between Loughlinstown Roundabout and Junction 9 (Glenview). The scheme is currently at the Options Selection phase (Phase 2 of TII's Project Management Guidelines).

A non-statutory public display on the emerging preferred options for sections A and C took place in November 2022.

A further non-statutory public display event was held in the Glenview Hotel in September 2023 that presented the overall emerging preferred option for the BPIS between Loughlinstown Roundabout and Junction 9 (Glenview).

The public display documents are available to view on the project website www.n11m11bpis.ie.

A significant negative response was received during the public consultation to the proposed closure of the N11 access to the Herbert Road.

Further environmental studies and traffic analysis have now been completed on elements of the emerging preferred option. As a result, further consideration is now being given to the preferred options at J8 Kilmacanogue, J7 Bray south (including Herbert Road access) and J6 Fassaroe (including the R117 access).



N11 Parallel Service Road at Kilmacanogue

A noise assessment to the east of the new Parallel Service Road Scheme was carried out during April and May 2022. The options review and design commenced in March 2023 following confirmation of funding from TII. Site investigation works were completed in November 2023. This information has been reviewed by the Design Team and the final design option has been prepared to allow direct consultation with the affected residents. The procurement of a works implementation contractor is the next phase of works for the project team.

N81 Knockroe Bend Realignment

Tenders for a Per-Cent Art Feature are being procured by the Arts Office. The preferred feature has been selected pending the completion of the final assessment stage.

N81 Irishtown West, Whitestown Lower, Hangman's Bend and Tuckmill Lower "N81 Four Studies"

Following completion of Phase 1 feasibility studies (The N81 Four Studies – Feasibility Report), Wicklow County Council are now progressing the following two projects:

N81 Whitestown Lower Project; and

N81 Hangman's Bend and Tuckmill Project.

The Phase 2 Options Selection work is currently progressing under TII's Project Management Guidelines. A non-statutory Public Display event on the Route Options took place in the Inis Fail Germaines, Main Street, Baltinglass, on Wednesday 27th March 2024. The public display documents are available to view on the project website www.N81whitestownandtuckmill.ie with submissions accepted from Wednesday 27th March 2024 to Friday 26th April 2024.

N81 Pavement Capital Works

Advance drainage works have been completed and the resurfacing works of 1km of the N81 between Tuckmill and Saundersgrove are now expected to commence in April 2024.

N81 Hollywood Cross Rural Traffic Calming Road Safety Improvement Scheme (RSIS)

The Feasibility and Options report was finalised and approved by TII in November 2023. TII have also approved funding to proceed with the design phase in accordance with TII Standards. The preliminary design report was submitted to TII in March 2024 following which a Pre-Part 8 briefing was provided to the members of Baltinglass Municipal District on the 25th March 2024. The Part 8 statutory process commenced on the 28th March 2024 with the period for submissions by interested parties due to end on the 14th May 2024.

Park & Ride/Share at Hollywood

A feasibility report, funded by the Baltinglass Municipal District was prepared and submitted to TII in Oct 2021. This report considered an option for parking accessed from the N81. TII subsequently provided funding to further examine the feasibility and options.

TII have indicated that they do not support the proposed additional access to the N81. As a result, the option for a parking facility accessed from the N81 has been discounted from the current scheme. A way forward is to consider suitable parking locations, which can be accessed from the regional/local road network.

N81 Blessington Gateway Project

The Feasibility and Options report was finalised and approved by TII in October 2023. TII have also approved funding to proceed with the design phase in accordance with TII Standards. Wicklow County Council will now progress this project to the design phase to be followed by any necessary statutory approvals process.

N11/M11 Strategic Bus Park & Ride Facilities

Proposals for bus-based Park & Ride facilities are being progressed adjacent to the N11/M11 at Junctions 6 (Fassaroe), Junction 11 (Kilpedder) and Junction 16 (Ashford/Rathnew).

The Chief Executive's report, that followed the part 8 public consultation for the park and ride at Junction 6 Fassaroe, was presented to the full meeting of Wicklow County Council on the 6th November 2023 where it was passed following a vote by Councillors.



The design for the Bus Park & Rides at Junction 11 (Kilpedder) and Junction 16 (Ashford/Rathnew) are being progressed in conjunction with the NTA Park & Ride Delivery Office.

Arklow Public Realm

The Parade Ground Public Realm works are complete on site. Following a meeting with DoHLGH, Project Completion Reports were submitted with additional funding requested in December 2023.

Arklow to Shillelagh Greenway

After the successful non-statutory public consultation, we are currently reviewing submissions received as part of the public consultation process. We are in the final stages of Phase 2 Options Selection, which will determine the preferred route for the Greenway with landowner consultation ongoing. Following this, we will proceed to Phase 3, involving Design and Environmental Evaluation.

Baltinglass Town Centre Plan

Enabling works started in Baltinglass in mid-February with the WCC Direct Labour crew completing site investigation works and have started utility works. The consultants are actively engaged in preparing documents for the delivery of a revised tender package for the town centre works, focusing on a reduced scope.

Blessington Inner Relief Road

The current focus of the project is on the detailed design phase, including the preparation of associated documents such as the Compulsory Purchase Order (CPO) documentation. These efforts are crucial to advance the scheme towards obtaining statutory approval. Given the potential impact of the project on the Poulaphuca Special Protection Area (SPA), it is necessary to prepare a Natura Impact Statement (NIS) to assess and document any potential effects on the SPA. Once the detailed design and associated documents, including the NIS, are completed, the project will proceed to seek statutory approval from An Bord Pleanála.

Wicklow County Council Compulsory Purchase (Chapel Road Pedestrian and Cycle Infrastructure Improvement Scheme) No. 1 Order 2021

The CPO Notice to Treat was issued on all landowners in October 2023. There is active engagement between Wicklow Roads Project staff and landowners who are part of the CPO, with landowner meetings taking place on November and December and January. Our project valuer is engaging with valuers and homeowners as part of the CPO process. Consultants are making steady progress in the detailed design phase and are currently focused on preparing the tender documents and drawings for the construction phase with these documents anticipated to be issued Q2 2024.

Wicklow Greystones Greenway

Wicklow County Council has recently engaged consultants Atkins for the project and their work is already in progress, focusing on data gathering. Additionally, the consultants are actively organizing detailed environmental surveys, which will play a vital role in shaping the route options and conducting constraint studies.

Meetings and information sharing is ongoing with Irish Rail for their East Coast Rail Infrastructure Protection Project. Meeting with the National Parks and Wildlife Service (NPWS) took place in June 2023. The meeting provided an opportunity to engage with the NPWS and discuss important aspects related to the project.

Greenway Project Consultant Atkins have issued a Constraints Report and a 4 week long public consultation period is currently underway for the emerging route corridors. The project was presented at the April Council meeting with two public events taking place in Greystones and Wicklow during April.

Blessington eGreenway

Under Section 177AE of the Planning and Development Act, we have formally submitted our planning documents to An Bord Pleanála. Given the need to conduct comprehensive additional surveys and generate a substantial volume of supporting material, An Bord Pleanála granted an extension to the submission deadline for additional information to January 29th 2024. As this information has been deemed significant additional information by ABP we are required to undertake a public consultation period again to take place in May 2024.



Active Travel Updates - March

Projects Under Construction

Ballyguilemore Active Travel Facilities (Wicklow MD)

Provision of new pedestrian facilities and road safety improvements along the Ballyguilemore Road between Carrig View and the entrance to the proposed new St. Patricks GAA Pitch. The scheme includes for new footpaths and road widening works. Construction works are progressing well on site, with embankment construction works completed on the western side. Public lighting works are ongoing.

Arklow South Cycle and Pedestrian Scheme (Arklow MD)

Provision of 2.8km of segregated cycle track along the R-772 Wexford Road, Arklow between Knockmore Roundabout and M11 Junction 21. The scheme will also construct 1.4km approx. of pedestrian footpath. Accommodation works are ongoing on the northbound carriageway. Preparation works have commenced for the slipform kerbing on the northbound carriageway.

Safe Routes to Schools: St. Kevin's National School, Greystones (Greystones MD)

Provide infrastructure for schools to increase walking and cycling as the preferred travel mode where possible and improve safety at front of schools. Front of school implementation works are substantially completed. Detail design being completed for the footpath connection from Church Lane. Consultation to be undertaken with school and local residents.

Safe Routes to Schools: St. Johns Senior National School, Arklow (Arklow MD)

Provide infrastructure for schools to increase walking and cycling as the preferred travel mode where possible and improve safety at front of schools. Front of school implementation works are substantially completed. Contractor to be appointed to lay the High Friction Surfacing (HFS).

Safe Routes to Schools: SS Michael and Peter Junior School (Arklow MD)

Proposals to improve road safety and make the areas adjacent to the schools safer, so that children can be encouraged and facilitated to walk and cycle to the schools safely. Construction works are substantially completed. Contractor to be appointed to lay the High Friction Surfacing (HFS).

Project Updates

Bray Dart Interchange (Bray MD)

New plaza and public transport interchange in front of Bray DART station, with revised car parking, set down and taxi rank arrangements. David Walsh Civil Engineering have commenced works on site.

David Walsh Civil Engineering commenced ground works in Mid-February. Works are ongoing on the installing the new drainage system for the project. Sod turning event took place on 18th April and was attended by Minister Eamon Ryan.

Wicklow Active Travel Pathfinder Project (Wicklow MD)

The project scope has been changed and will focus on the provision of high-quality pedestrian and cycle facilities along R750 from Wicklow Town Car Park and along Station Road. It will also include the provision of a new pedestrian and Cycle Bridge linking Station Road to Wicklow Town relief Road. Traffic surveys have been completed and work is ongoing on the preliminary design for the route.

Greystones Active Travel - Pathfinder Project (Greystones MD)

Provision of new and improved pedestrian and cycle links to Greystones Train Station. The spine route extends from Greystones Marina to Shoreline Sports Centre. The project will include improved pedestrian and cycle crossings along the Charlesland Dual Carriageway. Baseline assessment required by Department of Transport as part of Pathfinder. Design of pedestrian crossings on Charlesland Dual Carriageway agreed with NTA. Tender documents are being prepared for contractor to carry out the construction works at the roundabouts on Charlesland Dual Carriageway. Rapid Build Options Report for the spine route has been approved by NTA and work is ongoing on the preliminary design for the spine route.

Safe Routes to Schools: Scoil Nioclas Naofa, Dunlavin (Baltinglass MD)

Provide infrastructure for schools to increase walking and cycling as the preferred travel mode where possible and improve safety at front of schools. The Preliminary Design has been prepared and issued to NTA for approval. The Preliminary Design was presented to the Baltinglass MD Members on 22nd April.



Kilcoole Road Footpath (Greystones MD)

Footpath to be constructed linking Greystones to Kilcoole. Meeting held with landowner to discuss accommodation works. A design has been prepared and issued to the landowner for agreement. Once the design is agreed a tender will be run to appoint a Contractor. It is hoped to begin construction in Q3 this year.

Convent Road Active Travel Scheme (Greystones MD)

Design and implementation of One-Way system on Convent Road with pedestrian and cycle improvements. Preliminary design has been prepared and work is to start to prepare Part 8 documents.

Safe Routes to Schools Programme - Round Two Schools

Greystones MD - Gaelscoil na gCloch Liath, Greystones Educate Together, Temple Carrig School Bray MD - Kilmacanogue NS, Baltinglass MD - Scoil Niocláis Naofa. We have received delivery plans from An Taisce for these Round 2 schools, with feedback provided. We have commenced in-house on the preliminary designs for these schools.

Bridge Rehabilitation (Local and Regional Roads)

During March and April, works were carried out at 3 more bridges with our crew.

Colbinstown Bridge is currently being assessed by OCSC and others for remedial works.

Machinery Yard

Works continue the maintenance of council vehicles, plant, and machinery. In particular Winter maintenance vehicles and surface dressing vehicles.

The application for a Dangerous Substances Licence has progressed to compliance with conditions.

All 3 fitters have completed their training in the maintenance of electric vehicles.

Winter Maintenance

The season finishes on April 30th. It has been a relatively mild winter.

From March 19th to April 24th there have been 2 nights gritting.

Surface Dressing

Preparations are underway for the season which is planned to start in mid-May.

Materials are being ordered and all H&S documents are being updated.

The Vacant Property Refurbishment Grant is a payment you can get if you are turning a vacant house or building into your permanent home or a rental property. The grant applies to qualifying vacant properties in cities, towns, villages and rural parts of the country.

A grant of up to €70,000 is available.


If the refurbishment costs exceed the standard grant of up to €50,000, a top-up grant amount of up to €20,000 is available.

To qualify for the grant, applicants must:



- Have proof of ownership or evidence of active negotiations to buy the property (that is, confirmation of
 engagement from the estate agent or owner of the property) where you are seeking approval in principle for a
 grant.
- Live in the property as your principal private residence or make it available for rent.
- have proof that the property has been vacant for at least 2 years and that it was built up to and including 2007.

Emergency Services

Operational Fire Statistics April 2024

There were **97 incidents** attended during the month of March 2024. Due to laid down procedures to mobilise two stations to potentially serious incident types, individual Fire Stations were mobilised on a total of **119 occasions** including **10** mobilisations in other counties. On no occasion did an incident commander request additional resources over what was prescribed in the Pre-Determined Attendance.

Operational activity for the month of March 2024 **increased by 25% (+24 mobilisations) on the preceding month** (February 2024: 95 mobilisations). There was an increase in mobilisations to RTCs (+7 mobilisations), automatic alarm activations (+5), malicious outdoor fires in urban areas (+5), Vehicle fires (+5), gas leaks (+3) and incidents in neighbouring counties (+4).

Operational activity for the month of March 2024 **increased by 7% (+8 mobilisations) on the equivalent month in 2023** (March 2023, 111 mobilisations). Year on year RTCs increased by 13 mobilisations and there was an increase in chimney fires (+5), but there was a decrease in domestic house fires (-6) and a slight decreases in a number of other incident types.

There has been an exceptionally high increase in both Commencement Notice and Certificate of Compliance on Completion submissions compared to the same period in any previous year. The Temporary Waiver in respect of Development Contributions is leading the urgency in submitting Commencement Notices prior to April 2024. The Temporary Waiver has now been extended until December 2024 and existing levels of submissions is predicted to continue. The assessment process of current levels of submissions to BCMS is unsubstantial with existing resources available to Building Control.

BER certificates for all newly completed units were requested & submitted to Building Control as per S.I. No. 243/2012 - European Union (Energy Performance of Buildings) Regulations 2012.

APRIL 2024



Building Control continued with a lower level of site inspections in March to identify non-compliances with Building Regs onsite and 2 Section 11 Compliance Requests were issued. With current resources available to Building Control & unprecedented levels of BCMS submissions resources have been focused on administration of submissions.

Revised Information requests remained high in March for both Commencement Notices and Certificates of Compliance on Completion, 75% of Commencement Notice submissions & 30% of Certificate of Compliance on Completion submissions required revised information. It should be further noted that some Opt Out Submissions are requiring 2 to 3 Revised information requests which results in submissions being assessed 2 to 3 times to ensure compliance prior to commencement.

Opt Out submissions are both extensions and single unit dwellings, generally from BCMS users who are unfamiliar with both BCMS and Building Regulations which leads to Building Control resources being directed to resolving both administration and technical issues with Opt-Out Submissions. Wicklow Building Control continues to perform rigorous assessment of submissions at commencement stage and onsite presence during construction. These methods remain the best way to promote compliance with Building Regs.

In March, Building Control staff also attended Eastern Region Quarterly Meeting in Navan and Annual Building Control Conference in Sligo.



Information Systems

Operations

• The IT Helpdesk continues to streamline the workflow for the technical support team with an average of 50 tickets a day this month, providing assistance for both in-house and remote workers.

GIS & Systems Analysis

- Following a meeting with ESRI-Ireland regarding Climate Fund Application software, the Climate Action team has been assigned AGOL accounts for evaluation purposes.
- In collaboration with the Roads Department, a meeting was held regarding the Noise Action Plan and data return, prompting plans for installing ArcGIS Pro to make the data publicly available.
- Progress has been made on green infrastructure mapping for the Arklow LAP and zoning layouts for Greystones/Delgany and Kilcoole LAP.
- Review of Disabled Parking Spaces in Bray MD was undertaken.
- Efforts to update Wicklow's draft zoning layer for Local Area Plans are ongoing.
- Progress continues on reviewing existing zoning plans for Wicklow Town-Rathnew and advancing zoning plans for Greystones-Delgany and Kilcoole and Arklow areas.
- Maps depicting local electoral areas and polling districts have been developed.
- Stormwater layers on the ArcGIS viewer have been updated in collaboration with the Roads Department, incorporating new data on stormwater infrastructure and drainage systems.
