

**PUBLIC CONSULTATION.
CCTV SYSTEM FOR BALTINGLASS TOWN CENTRE.**

1.0 Introduction

1.1 Wicklow Co. Council in association with An Garda Siochana are considering the installation of a new Closed Circuit Television (CCTV) System in Baltinglass Town Centre.

2.0 Baltinglass Town Centre CCTV System Objectives:

- 2.1 The main objectives of the Baltinglass Town Centre CCTV system are to;
1. Provide a deterrent to crime and anti-social behaviour.
 2. Improve public safety.
 3. Assist emergency services when investigating an incident.
 4. Gather evidence for the detection and prosecution of persons who may have been involved in criminal activity.
 5. Assist the Local Authority in the management of public areas which is essential to the commercial wellbeing of the town.

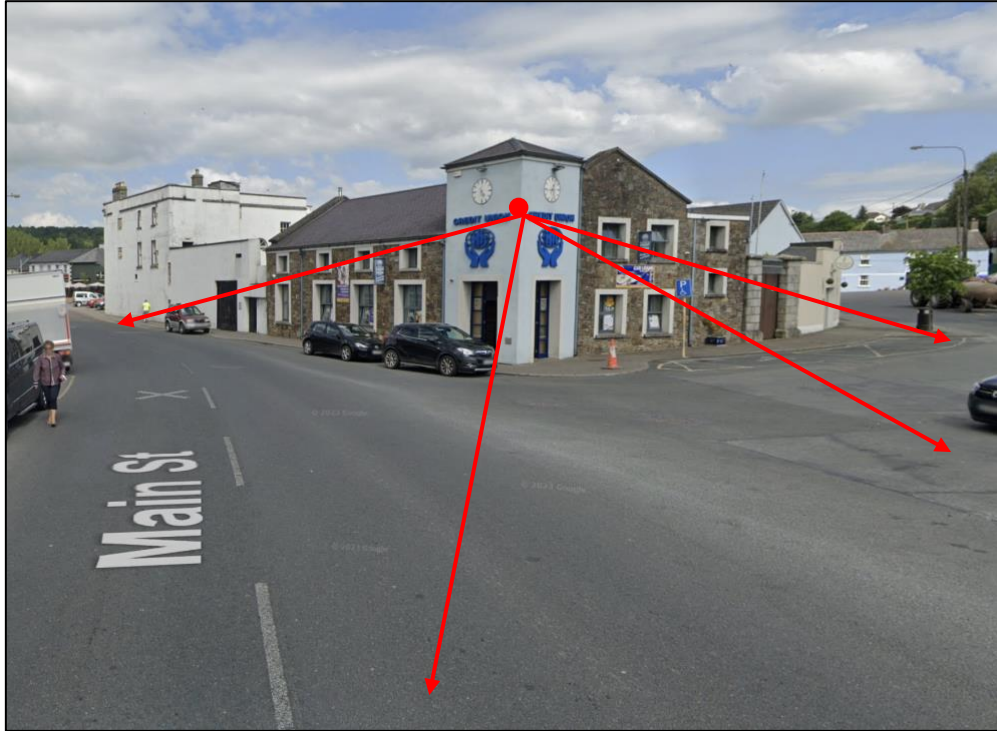

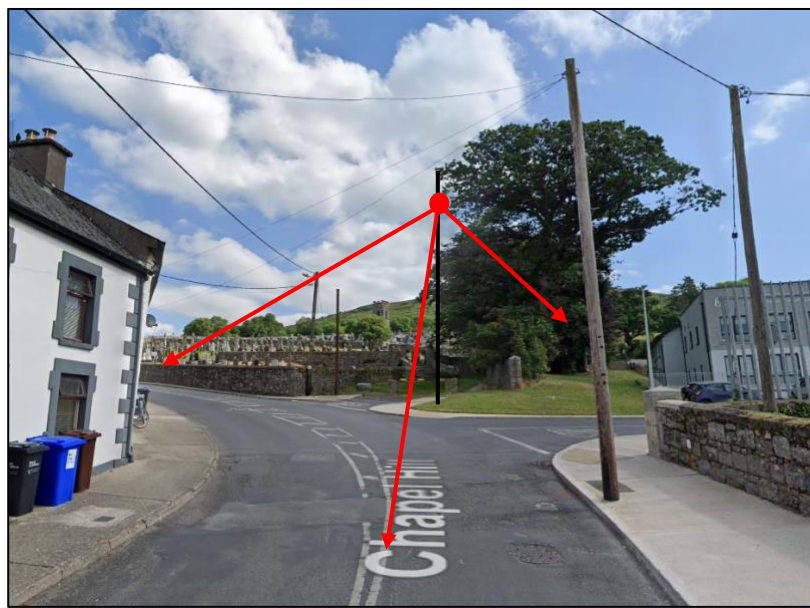

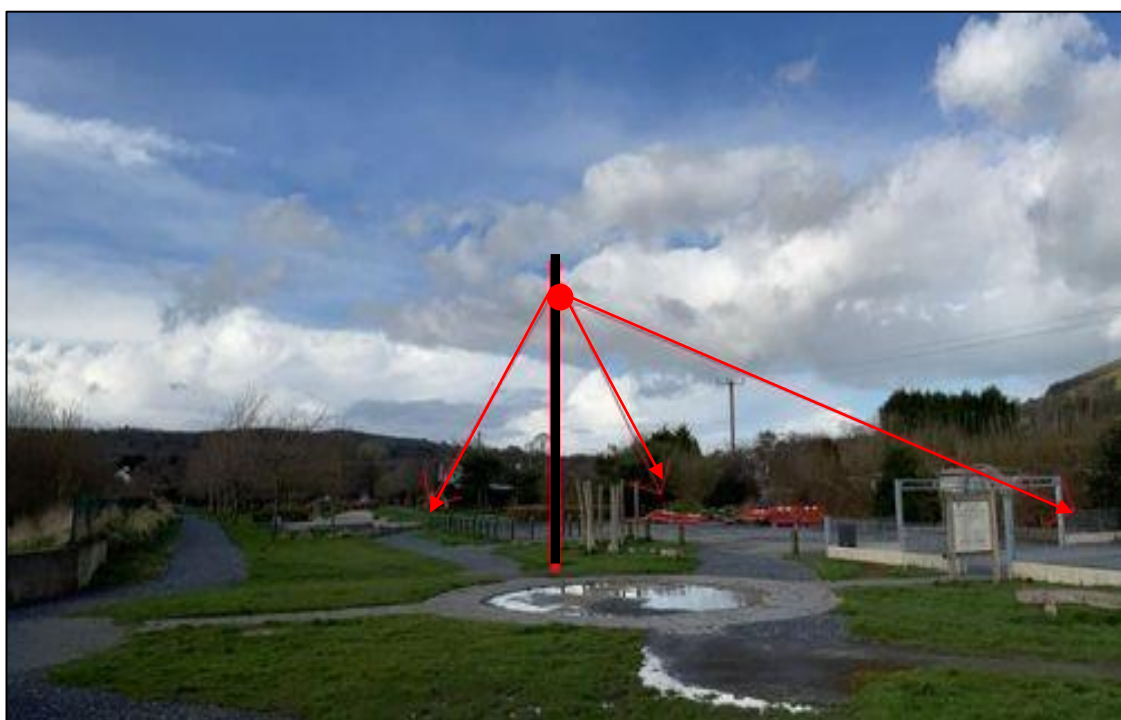

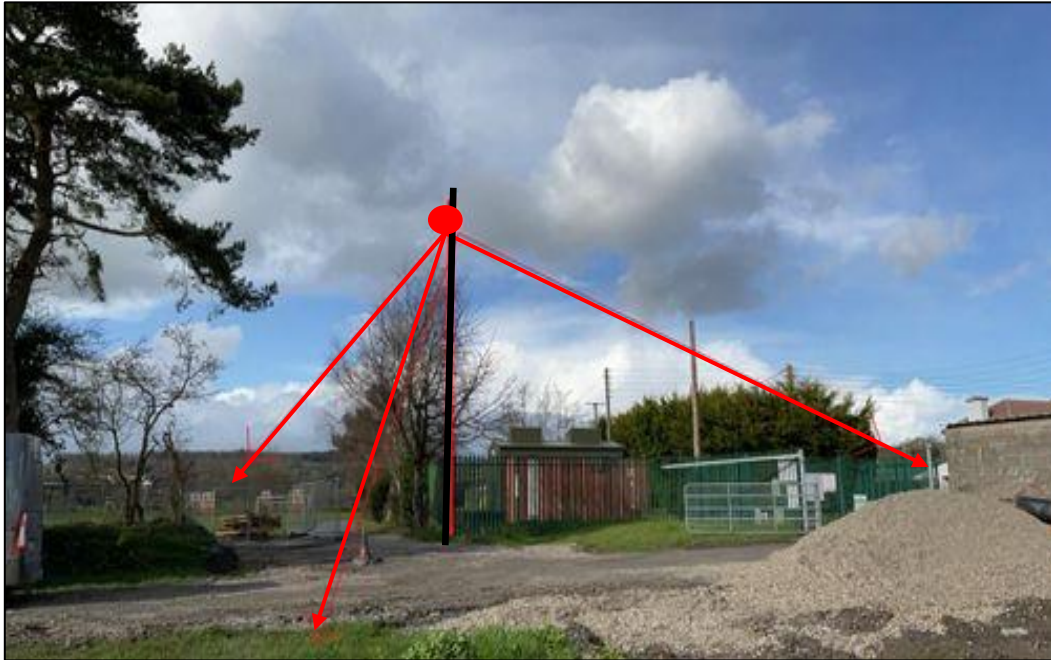

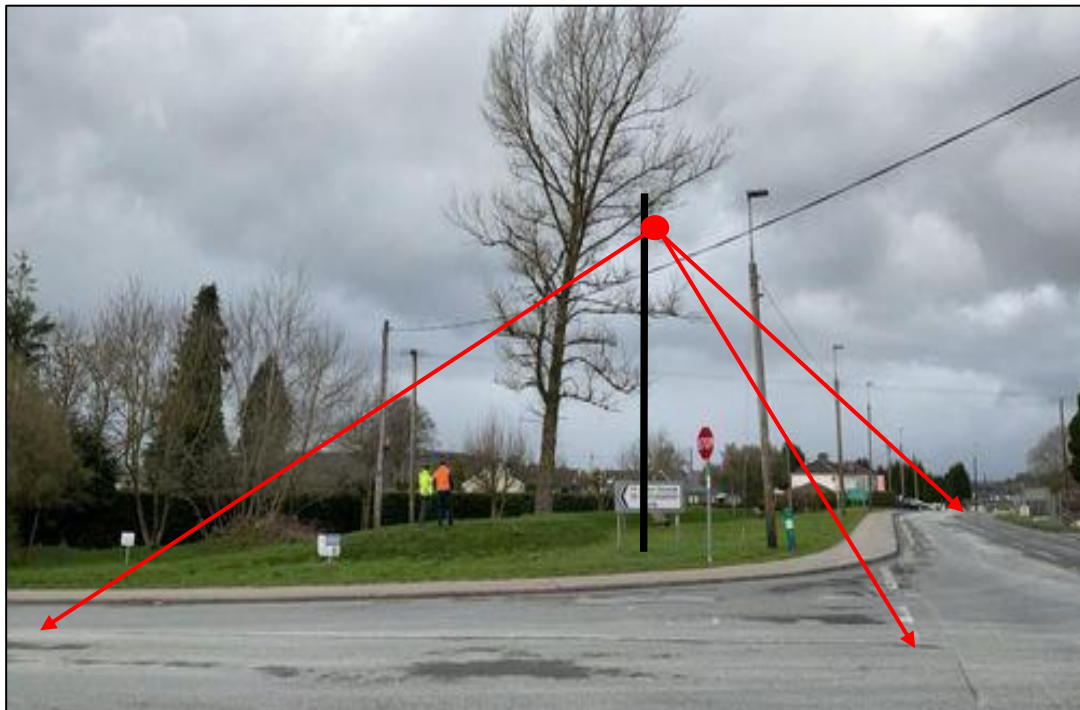

3.2 The total number of cameras proposed for the Baltinglass CCTV system is 9 installed at 9 locations throughout the Town ie.

- 6 x 3 Lens Multisensor cameras.
- 3 x 4 Lens Multisensor camera.

3.3 The system will provide CCTV coverage of Baltinglass Town Centre and adjoining areas in line with Wicklow County Council and Garda requirements.

3.4 The CCTV server will be based at Baltinglass Library.

3.5 Wicklow County Council will be the Data Controllers for the CCTV system and will manage all Data Protection/GDPR matters related to the system.

3.6 An Garda Siochana, Baltinglass will be provided with a live link to the system.
