### **Archival History/ Source of Acquisition**

The collection was created over many generations of the Acton Family. It was maintained by the Acton Family up to its transfer to the National Archives of Ireland to be held in trust for Wicklow County Council Archives in 2008. The collection was then transferred to Wicklow County Archives on 19 December 2022, where it is housed and available for researchers to view. Acton family papers were also donated to the National Botanic Gardens of Ireland.

### **Biographical History**

The Acton Family history in County Wicklow dates back to the Cromwell period. Thomas Acton I, leased Bog Hall, Ballygannonbeg from Walter Byrne during the early seventeenth century. By the 1690's he leased Kilmacurragh from the Parson family. Thomas married Elinor Kempston and had a son, William and three daughters. Thomas was one of three Grand Jurors responsible for a new workhouse in the Borough of Wicklow, which opened in 1715 and was one of the first landowners in Ireland to plant trees on a grand scale. Thomas was succeeded by his son, William. William became a barrister and rose to become Keeper of the Writs of the Court of Common Pleas. He was also a member, or Serjeant, of the exclusive Order of the Coif from which all judges of the Court of Common Pleas (King's Bench) were

appointed until 1839. On 04 March 1736 he married Jane Parsons, second daughter of William Parsons, of Birr Castle. William and Jane had two sons and three daughters. The second son Thomas was the successor to Kilmacurragh.

Between about 1750 and 1850 Kilmacurragh became known as West Aston. Thomas married Miss Sidney Davis, daughter of Dublin barrister Joshua Davis. They had two sons, William and Thomas, and two daughters, Anne, Maria and Jane. The eldest son William succeeded to West Aston on Thomas's death in 1817. During the 1840s, William added two single story wings to the main house, which now reverted back to Kilmacurragh rather than West Aston.

On 16 June 1818 William Acton married his first cousin, Caroline Walker. Her father Thomas Walker lived at Tykillen in Co. Wexford and was a Master of Chancery. Her mother Maria was William's aunt. They had seven children; three boys (Thomas, William and Charles) and four girls of which three girls died (Maria (16), Sidney (20) and Caroline (12)) only Irene survived. William died aged 65 in April 1854, Caroline Acton, died a quarter century later on 11 April 1879. Thomas succeeded his father in Kilmacurragh. He expanded the gardens of Kilmacurragh with his sister Irene Ball Acton.

Thomas remained a bachelor and upon his death on 25 August 1908 he was succeeded by his nephew, Charles Annesley Acton, son of Charles Ball Acton and Georgina Cecilia Annesley. Charles died aged thirty-nine in WWI leaving Kilmacurragh to his only surviving brother, Major Reginald Thomas Annesley Ball-Acton. In April 1913 Reginald married Isabel Richmond, second daughter of the Rev. William Richmond, Rector of Rockhampton, Gloucester. On 22nd May 1916, barely eight months after his brother's death, Reginald was killed in action at Ypres leaving Kilmacurragh to his baby son Charles. Charles's mother, Isabel Acton, married Hugh Norman Digues La Touche, son of James Digues La Touche.

However, the house was abandoned during the 1920s and fell into disrepair until rented by a German, Charles Budina, who ran it as a hotel offering continental cuisine. From 1932 to 1952, Kilmacurragh Park Hotel was one of the best-known hotels in Ireland. After 300 years in the family, Charles Acton had sold the property in 1944. Shortly afterwards the hotel closed down. In 1956 it opened briefly as an Irish Summer School. The Land Commission acquired the property in 1974 and presented 58 acres comprising the house, arboretum, walled garden and entrance drive-way to the Forest and Wildlife Service. Two devastating

fires in 1978 and 1982 left the house derelict. However, the grounds are now the site of the National Botanic Gardens of Kilmacurragh.

### **Content and Structure**

The collection contains many important papers dating back to 1640. From original deeds to correspondence between the landlord, his agent and the tenants of his estate. The collection has been catalogued chronologically by legal papers and correspondence to tenant and estate matters and accounts and finally, to personal and general correspondence of the Acton family.

Townlands covered in the estate collection include Carrigmore, Ballygannon beg, Ballgannon more, Coniamstown (Cunniamstown), Newbawn, Kilcandra, Tullylusk, Kilmacurragh, Ballynacooly, Bolagh, Kilmanogue, Ballyvaltin and Cloragh. Details include townland sizes and rents, and also correspondences from tenants on these lands to the Actons.

The collection houses many interesting papers, for example a threatening letter dated 1881 from *Captain Moonlight* to John Hudson accusing him of "land grabbing". The estate account books detail men and women who worked in Kilmacurragh and their wages. There is a document describing the travel from Wicklow to Dublin during the 1798 Rebellion and children seeing rebels' bodies scattered along the road, to the extent that they were no longer shocked be the image. A proclamation dated 1742, where King George II's sheriff was to hang from the Church door, seeking John Bury for payment owed to Acton. Later correspondence in the collection also refer to Home Rule and WWI in letters between Kemmis and Acton.

This collection will give readers and researchers a vast amount of information on the relationship between landlord and tenants in the late seventeenth to the early twentieth century.

# **Scope and Content**

It includes original deeds, leases and wills. There is a vast collection of correspondence between landlord and agent detailing tenant issues and rents. The collection contains accounts for the Estate, detailing rents, leases held and also account books listing men and women that worked in Kilmacurragh house and their wages. There are documents relating to loans taken out to provide improvement works to Kilmacurragh house and stables. The collection holds

receipts for general expenses of the house but also county cess, poor law and tithe rent of the

county. It contains information on income tax for the Acton family over many years,

investments and insurance policies of the estate. There are also some documents relating to

the Kilmacurragh Gardens, in particular a 'Field Botanist Diary' of plants and their locations.

Documents are arranged from fonds to item level description.

Acton declined; Burkett replied expressing his disappointment at lack of support from his landlord. Request from Acton that Burkett vote for tenant Benjamin Farrar to be a Poor Law Guardian to reduce Poor Law rates in Dunganstown West and reply from Burkett that he will comply.

Letter between Kemmis and Acton relating to Bellpark mortgage farm conditions, crop and animals, rents and payments, income tax, list of lands in Captain Acton's control, condition of Mrs. Ball Acton, Luke Byrne, grazing, and the inability to get Hyland's rent that Kennedy should be requested to sort the issue. Letters refer to Sheaue, Grange Con and tithe rents.

Hyland mortgage sold by Hibernian Bank. Bellpark and the sale of Mrs Mauly's holdings sold to Cosgraves of Cullen. Lands of Ballinaskea to sell for £2,000. Also, Kemmis has new address 25 West Mall, Clifton, Bristol.

Letters also mention the Home Rule Bill, Clancy of Macreddin extention due to the death of his wife and child, socialism and taxes. A new address for Kemmis Kilmington, Oxminister, Devon.

Years correspondence between Kemmis and Acton that discusses collection of rents, the railway strike, the Meath question under the Land Commission. Letters mention Linehan, the lands of Bellpark, Richard Hill and a loan for his water. Sharpe on the letting of Ballinaskea.

Sheaue's holdings. Weather mentions a sixteen-week drought then followed by two day and two nights heavy rain.
