

- County wide remit with some collaborative connection and inter-county networking
- Importance of making connections locally and building practice and reputation in the immediate context.





Background

The Arts Act Funding Scheme is integral to Wicklow County Council's broader efforts to encourage excellence in the arts and enhance community involvement in artistic endeavours across the county.

Applications can be made under the following three schemes:

- Artist Award
- Artist & Communities Collaboration Award
- Arts Festival Award

Applications are welcome from all art forms including film, music, visual arts, theatre, dance, literature, architecture, animation, performance, circus, traditional arts, music and drama.

This scheme aims to enable artists to:

- □ Develop and/or present new work
- **└**, Consider new approaches to their work
- □ Connect with international networks, organisations and practitioners, to develop future collaborations

While the maximum award available is €5,000, awards are often made for lesser amounts.

Who is Eligible to apply?

This award is open to all professional practising artists across all art forms and genres. Applicants must be native to County Wicklow or residing in County Wicklow for the past three consecutive years.

Who is not eligible to apply?

- **∟** Undergraduates
- **□** Persons currently in full-time education
- □ Persons not native to County Wicklow or not residing in County Wicklow for the past three consecutive years

Categories not eligible

- **↓** Full-time undergraduate education
- □ Any project which has already begun or is underway (unless what is proposed is a distinctive second phase or subsequent development)

- Self-publishing within literature; CD production within music; materials within the visual arts (paint/canvas etc.); bridging finance; final editing; etc.

Assessment Criteria

- Excellence (latent or achieved) of artistic practice: Provide evidence of a robust and proven professional arts background (through the applicant's CV and accompanying documentation)
- Quality and innovation of approach: Demonstration of inventive, ambitious, high-quality and innovative approaches in applicant proposals (including embracing digital or virtual practices)
- Distinctive benefit to artist's professional practice: Outline how the proposal will distinctly benefit the applicant's professional growth as an artist and/ or professional practice outputs
- Feasibility and viability of proposal (including evidence of advanced planning): Provide a well-defined project timeline (for project completion within the timeframe of the Award). Financial Feasibility: Provide a breakdown of project expenses within your budget including a breakdown of any additional sources of funding or income (including evidence of finances received, permissions and/ or licenses already in place).

The Artist & Community Collaboration Award facilitates artist and community partnerships in any artistic discipline or genre. This Award is aimed at creating and delivering high-quality projects or programmes that nurture the creative growth of both the artist and the community.

This award funding is designed to cover one of the following areas, either partially or in full:

It's essential to note that the maximum award available through this scheme is capped at €5,000.

What is not eligible? Ly For-profit or fundraising projects Ly Deficits or start-up costs for new organisations Ly Entertainment/hospitality expenses Ly Projects where the majority of activity takes place outside County Wicklow Ly Insurance costs where it is more than 10% of the awarded amount Ly Capital improvements Ly Proposals where the majority of costs relate to

equipment hire/ administrative costs

Before submitting an application, artists and community groups are required to have already approached the respective artist or community group collaborator and must provide written confirmation of their commitment to the proposal.

Assessment criteria

The extent of collaboration evidenced:

Demonstrate a clear and considered plan describing how the collaboration will be developed and managed

Provide an overall timeline detailing project delivery, promotion and evaluation

Benefit to both artists and community:
— Outline how the proposal will distinctly benefit both the artist's professional growth and the community group's artistic growth

Excellence of artist's work: Demonstrate an inventive, ambitious, and innovative approach to the proposal Provide evidence of a robust and proven professional arts background (through the artist's CV and accompanying documentation)

Financial feasibility of proposal: "Provide a breakdown of project expenses within the budget including a breakdown of any additional sources of funding or income Background to community group and evidence of ability to deliver. "Demonstrate and evidence the lead applicant's ability to manage and deliver the proposal "Describe the community group's shared interests, broad objectives, and their proven capability in project management "Provide a well-defined project timeline (for project completion within the timeframe of the Award)

Arts Act Funding - both awards

- 5 page guidance notes to cover all aspects of the award. These are clear and give you everything you need to make a good application
- Deadline 3+ weeks from today 5 February 2025 at 4pm -Get started
- This is particularly important as letter confirming collaboration is needed for the Artist and Community Collaboration
- Both awards provide a valuable opportunity to research, develop, or build upon your art practice. The awards are quite open to allow for maximum opportunity for creativity

MAKING AN APPLICATION

- Ensure you have read the guidelines and other information thoroughly
- Before sending your application check it over to ensure there are no mistakes. Ask someone else to look over it for you, preferably someone who is a good writer.
- Send what you are asked to only
- Ensure your application is professionally presented. This can be achieved in an online application through making sure your proposal is clear, concise and well written

Cvs and biogs

- Detail recent experience first
- Document your track record as an artist
- Include other work and experience if relevant to your practice
- Submit material that supports your application, do not detract by including too much
- Submit 5 high quality examples of past work rather than multiple examples that confuse or are of a lesser quality.

THE BODY OF KNOWLEDGE PROJECT

Undertaken by UK based dance artists Sally Doughty, Rachel Krische and Lisa Kendall, Body of Knowledge is a research project that examines how the dancer's body can be considered as a living archive by collecting, articulating and disseminating experiences – dance related and other – that reside in the body. Treating the body as a living archive challenges more traditional archives that contain tangible artefacts and documents, and emphasises the knowledge that resides in, and with, the dancer.

The project was initiated after Sally, Rachel and Lisa gave presentations at the *Thinking Dance: Questioning the Contemporary* conference at Leeds Beckett University, UK, on 6 October 2015. We each offered a particular perspective on our engagement with performative archives and post-conference, Body of Knowledge as a research project was born.

- Also possible to add Relevant experience, e.g. teaching/workshops in your discipline, volunteering, work with children

Letter of support

- This is relevant to the Artist and the Community Collaboration Scheme. It is written by the chairperson or director of the community group
- It should outline briefly the plan for collaboration, its development and management as well as broad dates/timeline for the project
- It should detail the shared interests and objectives of the community group and artist
- It should discuss artistic benefit of the proposal to the artist and the community group

Sample letter

Read all documentation carefully.


Applications can only be submitted online.

Under the 'Apply Online' section on www.wicklow.ie, click on the 'Apply Here' link, choose the 'Submit' button next to the Award and complete the following:

L Enter all relevant details on the online application form

 □ Upload the completed budget template for 2025 available on our website.

- □ Upload supporting documentation including:
 - An up-to-date Artist CV (max 2 pages)
 - 5 examples of your work or items that demonstrate your track record. This can include images, reviews, letters of support, treatments, draft scores, and audio or video recordings (link to YouTube, Vimeo, Soundcloud, MP4 etc.)






Online Application Form



- Summary: up to three short points giving an overview of your proposal
- Concept: What do you want to do and why? What is your anticipated outcome?
- □ Approach: How you are going to do it? Who is involved?
- Ly Track record: How will your knowledge, skills and expertise support/ensure the project's success?

- □ Engagement: How will you reach and engage vour audience?



Application Tips



Make sure to regularly refer to the guidelines throughout the application process.

Focus on the Who, What, Where, When, Why and How of your proposal.

Provide clear and concise answers to the questions.

Use the Budget Template provided and complete all cells relevant to your proposal.

Combine your supporting documentation (texts, visuals, links to websites, recordings) and title all documents with name, title, short description, materials, dimensions, year etc.

Pitfalls of proposals

- Incomplete submission refer to checklist or include cover letter to detail contents
- Proposal is unconvincing, has not been properly thought out
- Concept is undeveloped, lacks details
- Concept does not connect with proposed context
- Submission of more than one idea is each concept clear?
- Incomplete budget or missing budget, budget template not used, as required.
- Concept lacks originality, similar to previous work. Concept is commercial as opposed to artistic
- Missing supporting documentation or no letter of support/commitment

Your CV and biog should be third person, not exaggerated, clear and concise.

Build confidence over time

- Do not apply for too many opportunities
- Take a targeted approach and go for things that suit you and your practice
- Do not be discouraged when unsuccessful
- Build on success
- Ensure that you are happy with all your applications and proposals so you gain confidence
- Speak to your peers about their experiences and maybe find collaborators to apply with
- Take advantage of opportunities to workshop applications
