Community Recognition Fund 2024 - €694,300 to deliver 7 community projects across County Wicklow in first phase of funding

The Community Recognition Fund 2024 aims to support the development of community infrastructure and facilities for the entire community, in recognition of the contribution being made by communities across the country in welcoming and hosting significant numbers of arrivals from Ukraine and other countries.

The Fund, administered by the Department of Rural and Community Development, follows an extensive consultation process with local authorities who submitted their individual list of projects for approval.

Wicklow County Council Supports the Tinahely Agricultural Show

The 2024 Tinahely Agricultural Show, which took place on Monday 5th August, is one of the largest and longest-running agricultural shows in Ireland and attracted over 20,000 visitors across the day and featured 400 trade exhibitors.

Wicklow County Council showed its support for the annual Tinahely Agricultural Show with a special marquee highlighting the Council's services and the county's attractions.

The show has been running since 1935 and continues to showcase the richness and diversity of rural life in County Wicklow with a huge range of entertainment, livestock competitions, equestrian events, arts and crafts, family fun and local food produce.

The show featured some of the best livestock in the country with over 1,000 entries in cattle, sheep, horses, ponies and poultry. It also hosted the Interbreed Cattle championships, sheep shearing and geese herding, along with an equestrian section which included show jumping, horse racing and pony games.

The wealth of creativity and talent within the local community and throughout the county was celebrated at the craft village which featured over 100 stalls selling handmade craft items including jewellery, pottery, woodwork and textiles. The show also had a food village where visitors could sample some of the finest local produce from County Wicklow and beyond.

Availability of contractors to carry out re-let refurbishment work continues to be the major limiting factor in turning around Voids/Re-lets. The Council can only recoup a maximum of €11,000 per house from the Dept of Housing Local Government and Heritage, whereas the average cost of relets was €36,000 per house in 2022 and €31,000 per house in 2023.

The overall vacancy rate for rental properties (private and social) on Census night was 7%, so our vacancy rate is less than half the overall rate for a rental sector where Local Authorities account for only 29.8% of the properties. Also, Wicklow County Council's vacant units only account for 3.2% of the total number of vacant units in our county.

Housing Maintenance

Planned Maintenance in the form of electrical remedial works is currently nearing completion at Parkmore in Baltinglass. Protech Electrical will then be moving on to Palladius Park in Donard.

Gas boiler maintenance Framework Agreements have been tendered on <u>www.supplygov.ie</u> for Baltinglass, Wicklow and Greystones MDs. Gaswise were successful tenderers for Greystones and Wicklow MDs and will start servicing on 29th of July. Bracken Plumbing & Heating were successful

tenderers for the Baltinglass MD and have started gas servicing in addition to oil boiler servicing already underway in that MD. Heat Pump maintenance contract documents are currently being prepared.

Private Rented Accommodation Regulation & Enforcement

The Targeted Inspection programme on private rented accommodation continues. Housing For All requires 25% of all private rented properties to be inspected annually. This equates to approx. 1500 properties in Co. Wicklow every year. Target properties are selected using a Risk Based approach. The Council is responsible for enforcing the Housing (Standards for Rented Houses) Regulations 2019 (SI 137 of 2019).

Prohibition Notices are published on the Council's website and there are currently 6 such notices (the oldest dates back to 2020). Note that in the case of properties subject of HAP, service of a Prohibition results in the HAP payment being stopped as per Section 41(2) (d) (i) of the Housing (Miscellaneous Provisions) Act 2014 and this happens within a maximum of 13 weeks.

Capital Assistance Scheme (CAS)

Wicklow County Council is continuing to support acquisitions under the Capital Assistance Scheme with Dublin Simon, Circle Housing, Ark Housing and Peter McVerry Trust, HAIL etc. Nine units were delivered in 2023.

Homeless HAP Place Finder

The Homeless HAP Place finder provides assistance in:

- Seeking out potential properties suitable for households currently identified as homeless or at risk of homelessness.
- > Liaising with specific households to establish their specific needs.
- > Establishing relationships with local property agents and landlords; and,
- Supporting those homeless households to (a) prevent the necessity to enter emergency accommodation or (b) to exit emergency accommodation and secure a tenancy.
- To date, 563 households (388 families & 168 singles) have been assisted under the Homeless HAP Scheme in Wicklow County Council from the inception on 1st October 2018 to 31st July 2024. (225 homeless cases, 314 prevention cases to date and 23 direct provision). 142 properties were sourced by WCC.

Addressing Homelessness in Partnership with Approved Housing Bodies

Homeless Supported Temporary Accommodation - Kilmantin Hill, Wicklow

Kilmantin Hill has 11 rooms to support persons either homeless, exiting a higher support facility, or in danger of becoming homeless.

There are 9 clients supported in the Kilmantin Hill facility, operated by Dublin Simon. There is continuous transition by the clients to suitable alternative accommodation.

A report is being undertaken at present to cost the refurbishment of the current rooms with a view to making them all ensuite. More details will be available over the coming months.

Homeless Family Service – Fitzwilliam Road, Wicklow

Dublin Simon are engaged by Wicklow County Council to operate and manage the facility at Fitzwilliam Road, Wicklow as a Family Homeless Service. The building comprises of three 1-bed units, two 2-bed units, and two 3-bed units. Eleven families have now transitioned or are in the process of transitioning to a permanent home and the resulting vacancies are in the process of being occupied with families experiencing or in danger of homelessness.

It is envisaged that families will avail of the service for circa 6-months STA (Supported Temporary Accommodation) with key working support to enable families to transition from homelessness into Homeless HAP, or alternative longer-term accommodation.

Homeless Supported Temporary Accommodation - San Remo, Bray

San Remo is operated by Dublin Simon and incorporates a service model whereby there are a number of emergency/cold weather initiative beds and Supported Temporary Accommodation Beds (STA). There is on site key working support linking in with clients.

The Neighbourhood Liaison Committee is now operational and meets monthly.

Bi-monthly meetings are held with Dublin Simon and Wicklow County Council staff

Homeless Supported Accommodation - Carraig Eden, Greystones

This facility provides 35 ensuite bedrooms with associated kitchens and common areas and is fully operational. Wicklow County Council run an in-reach service with the clients to support them as they continue their journey into more permanent accommodation.

Other Homeless Supported Accommodation

Wicklow County Council owned properties in Wicklow, Bray, and Greystones, leased to Approved Housing Bodies, provide 12 units of low to medium supported accommodation targeted to the particular support needs of the clients. Six of these persons living in shared accommodation have now successfully moved into their forever homes and this in turn created space to move further people out of homelessness.

A homeless outreach service has been rolled out in Bray and is proving very successful.

Housing First

Peter McVerry Trust has been appointed as the Housing First Programme Implementer for the Mid-East Region. Wicklow County Council is committed to working with them and has now reached and surpassed the targets identified in the programme. Housing First recognises that a stable home provides the basis for recovery in other areas.

Properties will be provided by both Wicklow County Council and Peter McVerry Trust for the implementation of the programme.

Wicklow County Council has, to date, successfully accommodated 18 clients under Housing First. Other clients proposed for Housing First have been assessed by the team and are availing of key support work pending finalisation of sourcing of accommodation. The main issue facing this programme is the availability of 1-bed units in suitable locations with easy access to required services.

Homeless Action Plan 2024 – 2026

The plan was approved by the elected members of Wicklow County Council at the Council meeting on 8th April 2024.

Ukrainian Response

As of the end of July 2024, there are 1,698 Ukrainian displaced persons in emergency accommodation, although it is known that there are significantly more in the county.

The breakdown of Beneficiaries of Temporary Protection is as follows:

- Arklow MD: 225
- Baltinglass MD: 358
- Bray MD: 756
- Greystones MD: 178
- Wicklow MD: 181

Wicklow County Council is currently assessing all displaced Ukrainians in the county to determine their accommodation needs and to connect them with relevant community services and supports.

Wicklow County Council is also working through a list of pledged properties within the county to match families with appropriate housing. To date, Wicklow County Council has housed 283 displaced Ukrainian individuals in pledged stand-alone 'Offer a Home' properties within the county.

Additionally, larger buildings and vacant units are being identified and explored as potential medium to long-term accommodation options.

Community

Community Recognition Fund (CRF) 2024

The Minister for Rural and Community Development, Heather Humphreys TD, announced on Friday, August 2nd, 2024, €16.5 million to deliver 185 community projects across the country. The major investment will support a diverse range of projects such as upgrades to sports facilities, community centres, parks, walking trails and playgrounds. As part of the initiative, funding is provided to support the purchase of buildings and vehicles for community use.

The Community Recognition Fund 2024 aims to support the development of community infrastructure and facilities for the entire community, in recognition of the contribution being made by communities across the country in welcoming and hosting significant numbers of arrivals from Ukraine and other countries.

The Fund, administered by the Department of Rural and Community Development, follows an extensive consultation process with local authorities who submitted their individual list of projects for approval.

County Wicklow Age Friendly Strategy 2023-27

Action 3.8 Appoint Healthy Age Friendly Homes Co-ordinator & Rollout Wicklow Programme

Healthy Age Friendly Homes (HAFH) Programme is a support coordination programme that aims to enable older people to age in place and reduce the need to transfer to long-term residential care. The Programme is a collaboration between the Department of Health and the Department of Housing and Local Government. It is funded by the Department of Health and operated by Meath County Council, on behalf of all Local Authorities.

The service is designed to enable older people to remain living in their own home for longer. The local coordinator undertakes home visits to older people living in the community, where a needs assessment is carried out, looking at four key areas of supports: housing, health, community/social supports, and technology. Home visits from the local co-coordinator are available to anyone aged 65+years. The rollout of the programme will commence in January 2024.

Older People's Council, Executive Group - Meetings and Representation

The Older People's Council (OPC) next meeting will be held in September 2024 in the Brockagh Centre, Laragh where issues such as Health, Transport and Technology will be discussed.

OPC Executive is planning for wider engagement with older people across the county and recruitment of more members of the OPC this year.

The Wicklow AGM will be held in the Arklow Bay Hotel on 1st November 2024. Various stands providing information to the older person will be provided.

Clinics for the Greystones area and Blessington area will be scheduled for later in the year.

Age Friendly Programme Manager and K.W.E.T.B. are organising a coffee morning regarding Digital Inclusion. Date to be confirmed.

County Wicklow Age Friendly Alliance

Next meeting will be held on the 9th of September 2024 where issues of Health, Transport, Housing and Socialisation will be discussed. Each member of the Older Persons Council will discuss the issues facing their own areas. Visits will be carried out to various clubs around the county. For example, Men's Sheds, Women's Sheds and Active Retirement groups.

"Care and Repair" for the Arklow Area – This is a programme aimed at helping the older person in the community avail of minor works being carried out around their home. Interviews will shortly be taking place. Initially this programme will be a pilot project following which a decision will be made regarding the viability of rolling out in other areas/towns within the county.

Age Friendly Ireland Committee

Wicklow Station has been nominated as the first train station within the County to receive Age Friendly Status. A Committee has been formed and the next stage of the project will be a walkability which is due to take place in September 2024.

"Beyond the Trees" Avondale and Rathcoran Housing Estate have been entered into the Business Recognition Awards. Shortlisting took place on the 12th of August 2024.

The Age Friendly Awards, which recognises business and companies who are mindful of Age Friendly will take place on the 7th of November 2024.

Disability Inclusion Steering Group (DISC)

A "Make Way Day" meeting was held on the 4th of July 2024. "Make way Day" is a programme that will be piloted to make people aware of the difficulties people with disabilities face when people park their cars on footpaths obstructing people with disabilities to pass by freely. It is hoped that this programme will be launched by the end of the year.



The Sunflower Lanyard Programme

The Sunflower Lanyard Programme aims to easily identify people with hidden disabilities. This Programme was launched in Wicklow County Council in April 2023. Members of the Customer Care Unit currently wear these Lanyards so that a person with a hidden disability can identify which member of staff will be able to provide additional assistance, if required.



Healthy Wicklow

Period Poverty Project – Healthy Wicklow has collaborated with The Colour Club to provide an educational piece to include gynaecological health for women throughout all stages of life, covering puberty to post menopause. *My Girls Gynae* will facilitate a series of workshops with the first "All About Puberty" being rolled out on Saturday 10th August targeting 10-13/14-year-olds and a family member.

Irish Heart Foundation Mobile Machine – Due to the success of the Irish Heart Foundation Mobile Machines onsite visit to Carnew Mart, Healthy Wicklow arranged for it to visit Baltinglass Mart on Wednesday 28th August. There were two nurses on hand to provide a free health check to farmers attending the Mart on the day.

Drumming Workshop – Nationwide are due to visit Carnew Community Care Centre and as part of this they will be focusing on the transition year intergenerational drumming project that was funded by Healthy Wicklow earlier in the year. In preparation for this visit a refresher drumming workshop for day care visitors/residents/students and staff will take place on Thursday 29th August.



Sláintecare Healthy Communities

Trauma Training

A two day in-person trauma training course with *Connected for Life* took place on the 25th and 26th of July, aimed specifically for the workers of the Bray Family Resource and Development Project. The training equips staff with the skills to identify trauma-related behaviours, offer appropriate support, and create a safe and nurturing environment, ultimately fostering better outcomes for children and young people.

Feasibility Study

We have recently received the first draft of our feasibility study, which has been in development for over four months. This comprehensive study focuses on identifying and addressing the needs of the Little Bray Community Centre and its surrounding green spaces, with the aim of optimising these areas for the benefit of the local community. The insights provided by this study will be crucial in guiding our future initiatives for Wicklow County Council and Bray. Our next step is to establish a steering committee in early September to review the results and determine the best course of action moving forward.

Other Activity

- The Integration Support Workers provided an information, advice and support session to the volunteers with Fáilte Isteach who are involved in English Language supports to the residents in River Lodge, Newtownmountkennedy.
- Wicklow County Council hosted the first Integration Support Coordinator Network meeting for the Easter and Midlands region.
- The inaugural meeting of the Community Integration Forum took place in Wicklow County Council on 25th July.
- The LAIT, in collaboration with the Wicklow Child and Young People's Services Committee and the Wicklow Sports and Recreation Partnership, delivered school camp placements for 91 children in IPAS centres across the county.
- The team arranged the first in a series of Further Education Information Sessions. The session was delivered by an Adult Education Guidance Counsellor with the KWETB. The session was attended by 9 IPAs, all of whom are interested in continuing education to improve their employment opportunities.

Consultations: Information circulated, and submissions encouraged in relation to two local consultations-Wicklow Council Draft Strategic Policy Committee (SPCs) Scheme; WCC Draft Polling Scheme.

Community information expo and training events being organised across the Municipal Districts in collaboration with Older People's Council, Co Wicklow Volunteer Centre and Arklow Community Excellence.

Social Inclusion Community Activation Programme (SICAP):

SICAP Mid-Year Reports 2024: The mid-year review of SICAP assesses progress on the SICAP Annual Plans from January 1st to May 30th. The mid-year assessment was very positive for both Bray Area Partnership and Co. Wicklow Partnership with all actions and key performance targets on or ahead of schedule and budget spend on track.

Additional New Arrivals Funding: Additional SICAP funding has been announced by the Department for work with the New Arrivals cohort i.e. International Protection Applicants, Ukrainians and recent Refugees requiring supports. Bray Area Partnership have been awarded €14,348 and Co. Wicklow Partnership €18,508.

Healthy Place-making, **Climate Action** and **Economic Opportunity** are the three overarching crosscutting themes that inform and shape all aspects of the plan. The plan also includes the Core Strategy and the Settlement Strategy for the County. The plan also includes the **Town Plans** for the following settlements: - Baltinglass, Newtownmountkennedy, Rathdrum, Ashford, Aughrim, Carnew, Dunlavin, Tinahely, Avoca, Donard, Newcastle, Roundwood, Shillelagh and Laragh-Glendalough. Variation No 2 to the County Development Plan 2022 - 2028 (Wicklow Town - Rathnew LAP)

We are currently preparing proposed Variation No. 2 to the WCDP 2022-2028. The purpose of the Variation will be to ensure consistency between the WCDP 2022-2028 and the draft and final Wicklow Town – Rathnew Local Area Plan, which is being prepared separately but alongside the Proposed Variation. Consultants have been appointed to carry out the SEA and AA for the Variation and the initial stages of the SEA screening is currently being carried out.

Local Area Plans

There are 5 Local Area Plans in Wicklow for the following settlements – 'Bray Municipal District', 'Wicklow Town - Rathnew', 'Greystones – Delgany & Kilcoole', 'Arklow & Environs' and 'Blessington'. We are currently reviewing all five.

Wicklow Town – Rathnew Local Area Plan

Pre-draft consultation closed for the new Wicklow Town - Rathnew Local Area Plan closed on 28 September 2023 with 84 submissions received. A well-attended public information day was held on 14 September 2023. All valid submissions have been reviewed and considered and a draft plan is being prepared. Once the draft plan is prepared it will go out on public consultation for 6 weeks with submissions invited from everyone. It is hoped that the draft plan will commence display in Q3 2024.

Consultants have been appointed to carry out the SEA and AA for the LAP and they are continuing to work on the SEA/ AA work. All other studies / assessments are intended at this time to be carried out in-house. Greystones – Delgany & Kilcoole Local Area Plan

Two well-attended public information days were held in January 2024. All valid submissions have been reviewed and considered and a draft plan is being prepared. Once the draft plan is prepared it will go out on public consultation for 6 weeks with submissions invited from everyone. It is hoped that the draft plan will commence display in Q4 2024.

Consultants have been appointed to carry out the SEA and AA for the LAP and they are continuing to work on the SEA/ AA work. All other studies / assessments are intended at this time to be carried out in-house.

Blessington Local Area Plan

The pre-draft public consultation stage of the Local Area Plan process ran from 21 February 2024 to 03 April 2024. An online consultation web portal was created for this stage, with submissions invited through the portal. 128 submissions were received. A well-attended public information day was held on 1 March 2024. Consultants have been appointed to carry out the SEA and AA for the LAP and they are continuing to work on the SEA/ AA work. All other studies / assessments are intended at this time to be carried out inhouse. It is hoped that the draft plan will commence display in Q4 2024.

Arklow and Environs Local Area Plan

The pre-draft public consultation stage of the Local Area Plan ran from 01 March 2024 to 02 April 2024. An online consultation web portal was created for this stage, with submissions invited through the portal. 80 submissions were received. A well-attended public information day was held on 15 March 2024.

Consultants have been appointed to carry out the SEA and AA for the LAP and they are continuing to work on the SEA/ AA work. Bray Municipal District Local Area Plan (including Enniskerry and Kilmacanogue)

Work has commenced on the review of the Bray Municipal District Local Area Plan. We are currently preparing an online consultation portal and are aiming to commence the pre-draft consultation in Q3 2024. Consultants have been appointed to carry out the SEA and AA for the LAP and they are continuing to work on the SEA/ AA work. All other studies / assessments are intended at this time to be carried out in-house.

Residential Zoned Land Tax (RZLT)

The Government's <u>Housing For All – A New Housing Plan for Ireland</u> has introduced a new tax to activate vacant land for residential purposes as a part of the 'Pathway to Increasing New Housing Supply'. The **draft** RZLT maps for lands liable in 2025 was published on 01 February 2024. Submissions were invited on the draft maps up to **01 April 2024 with 9 submissions received**. Submissions requesting a variation of the zoning of land are invited up to **31 May 2024 and no submissions were received**. Determinations on the 9 submissions were issued by 01 July. Landowners had until 01 August to appeal the decision to ABP in the determination. Vacant Site Levy

This programme is still ongoing and is affected by the proposed deferral of the RZLT. As liability to the RZLT is now proposed to be deferred for one year, it is considered appropriate to maintain provisions in legislation for the management and continued charging of the vacant site levy in respect of land which is identified on the register. This will continue to facilitate imminent placements on the register, conclusion of appeals and to facilitate the issuing of demands in relation to the levy for the period to the end of 2024. This will ensure that the use of the levy as an active land management measure will continue until the RZLT is in effect.

Heritage Office

Heritage Week in Wicklow: National Heritage Week takes place 17-25th August. Co-ordinated for County Wicklow by the Heritage Office. There are over 70 events registered on <u>www.heritageweek.ie</u> over the nine days and widely dispersed throughout the county, the majority are free of charge and family friendly

County Heritage Plan Review: The process of preparing a new Heritage Plan has commenced and public submissions are advertised and invited via e mail and/or online questionnaire by 30th July. A series of drop in clinics took place in each MD, May-June

County Heritage Plan (CHP): The Heritage Council have approved a funding allocation of €57,000 for projects under the County Heritage Plan Fund 2024. The following projects have commenced; County Heritage Plan Review, Glendalough Community Archaeology Project and Wicklow Community Archaeology Service.

Irish Community Archive Network (iCAN) – Five new community groups have signed up to the *Our Wicklow Heritage* network and are currently receiving training in setting up their digital archives. Training for Wicklow groups took place11th and 12th June.

Archaeology: Community Monuments Fund- CMF 2024. Six projects have been a successful in receiving funding allocations as per project applications prepared by the Heritage Office and submitted to National Monuments Service. All grants accepted and projects are in early stages of commencement.

Built Heritage Capital Funds (Architecture): A funding allocation of €101,000 has been received in respect of 16 projects shortlisted for county Wicklow under the Built Heritage Investment Scheme (BHIS). Additionally, four projects have been successful under the Historic Structures Fund (HSF) as follows; Coolattin House €171,000; Clermont House €171,000; Former Post Office, Shillelagh €20,000 and Vernacular house at Rosebank, Avoca €10,000.

Strategic Infrastructure Development

An Bord Pleanala has received an application for approval under section 182A(1) of the Planning and Development Act, 2000 as amended -ABP-310090-21- Proposed development will comprise the onshore grid infrastructure including 220kV export cable circuits and fibre optic cables, new 220kV GIS substation at Shelton Abbey and overhead line connection and all associated ancillary works. In the townlands of Johnstown North, Johnstown South, Seabank, Ballymoney, Killiniskyduff, Templerainy, Coolboy, Kilbride, Shelton Abbey, Ballyraine Lower and Ballyraine Middle, in Co. Wicklow – approved with conditions 27/5/2023.

An Bord Pleanala has received an application for permission under section 37E of the Planning and Development Act, 2000 as amended -ABP-309991-21 - Development and operation of an inert landfill facility to backfill the existing quarry to original ground level; progressive restoration of the backfilled quarry to longterm grassland/scrub habitat: establishment and operation of a construction and demolition waste recovery facility; installation and operation of a soil washing plant and all associates site works at Ballinclare and Carrigmore townlands, Kilbride, Co. E-Planning Project

The eplanning has now been in place for just over one year, it went live on 17th April 2023 and for the year up to 16th April 2024, we received a total of 1,437 applications of which 744 were received through the eplanning portal and 693 were received in hard copy, 51.8% in the first year were received online.

For the **month of July 2024**, a total of 111 planning applications were received of which 28.8% were hard copy applications and **71.2% were received online**.

From 1st January 2024 to 31st July 2024 a total of 777 applications were received of which 40.3% were hard copy applications and **59.7% were received online**.

Due to the complexities of larger applications, it has been necessary to request one hard copy for larger multi-unit developments.

There has been a mix of application types received during the month of July via the eplanning portal including:

- > A number of one off rural dwellings throughout the county
- > Change of use to a number of properties throughout the county
- > Extensions and alterations to existing properties throughout the county
- Construction of an energy storage facility at Templerainey, Arklow.

Economic and Rural Development

Town Regeneration

Blessington Town Centre First Masterplan

Blessington is a pathfinder town and is the first to receive funding for a Town Centre First Masterplan. The masterplan will provide Blessington with a clear framework to positively develop the town now and into the future. The implementation of the TCF plan is at the planning stage. RRDF funding will fund the redesign of the Main Street and Market Square and bring those projects to a shovel ready stage where they can be submitted for funding for Category 1 RRDF.

Funding Schemes

Town Centre First – Suite of Supports

Newtownmountkennedy has been announced under Phase 2 as one of the next 26 towns approved to develop Town Centre First Plans and has recently been approved for funding of € 30,000.00 under **Town Centre First Measure 2** Suite of Supports. This Town Centre First Plan must be completed and reports submitted to the Department by 5th September 2025.

Baltinglass, Rathdrum and Kilcoole have been selected for funding of $\leq 10,000.00$ for each of these towns under the **Town Centre First Town Team Support Fund – Measure 1.** This funding can be used to establish town teams where they are already not established or are at an early stage of development. The deadline for the drawdown of funding is 15/11/2024.

The Town Centre First Measure 3 Application closed on the 8th April. Two applications have been submitted for this Project funding,

1. Blessington - measures to include enhancement to the Square with tree planting and rain garden, spaces for dining and fixed seating.

2. Wicklow town – Further enhancement at the Black Castle area to encourage more tourism and attractions for locals with installation of picnic tables, seating and a sculpture park. A decision has not yet been received from the Department on this application

Thrive

Under the new Thrive Town Centre First Heritage Revival Strand 2 for Bray Courthouse and Heritage Centre an application was submitted to Thrive on the 3rd May. This application has not been recommended for funding by the THRIVE Evaluation Committee.

Town and Village Renewal Scheme 2023

Wicklow Co Council has been awarded €725,000 from the Department of Rural and Community Development under the Town & Village Renewal Scheme 2023. The Projects selected were Kirikee, Glenmalure for work on their Community Centre to include renovation of the roof, windows ceilings and walls; Lacken to renovate the old school house to be used as a community centre to include café and community shop and a small heritage section, and; Wicklow Town's Murrough BMX pump track to develop into a best- in–class asphalt covered pump track for all ages and abilities. The Acceptance Agreements have been signed and the commencement of the tender process will be discussed with the associated Town Team /Community Groups in early September.

Town Teams

We currently have four Town Teams, Arklow, Wicklow, Greystones and Blessington. Discussions are continuing on the future establishment of a Bray Town Team.

The process will commence for the formation of four new Town Teams, Newtownmountkennedy, Rathdrum, Kilcoole and Baltinglass in September & October 2024. The first Public meetings will start in early September with the aim of having the four new teams in place by December 2024.

The teams work closely with the Town Regeneration Office, attending meetings and giving information on funding and grants available to Town Teams

Rural and Urban Regeneration Development Fund Grant Applications Steering Group for the Progression of URDF and RRDF Projects

The Chief Executive has established an interdisciplinary team for the progression of Wicklow County Councils URDF (Urban Regeneration and Development Fund) and RRDF (Rural Regeneration and Development Fund) projects. The group meet monthly to streamline the advancement of RRDF and URDF projects along with a sub-group that will meet fortnightly and report to the steering group. This is a significant step in setting up the structures for town regeneration in the County.

Blessington RRDF: Blessington has been awarded over €1m funding under the Rural Regeneration Development Fund (RRDF) to be used for the regeneration of Blessington Town Centre, the development of plans for public realm works, the redevelopment of a vacant/derelict property to create an eHub and a Visitor Centre for the forthcoming Blessington Lakes Greenway.

Baltinglass RRDF: The costings for Baltinglass Gateway to Southwest Wicklow has come in over budget on both the public realm and the Courthouse refurbishment. The proposals have been revised and the necessary technical plans are complete in order for the works to commence. Works on the Public Park and playground are underway.

Application for further funding on this project was made to the Department on the 7th February 2024. However, the submission was not successful.

Newtownmountkennedy RRDF: The project is under review for revisions necessary due to contested issues regarding the design of the public realm. Once agreement is reached, the plans will be signed off and submitted for Category 1 funding.

URDF: Urban Regeneration Development Fund

URDF Call 3: Wicklow will receive €2.5 million to assist long term vacancy and dereliction. Four properties have been chosen (two in Arklow and two in Wicklow). An information gathering notice has been published on a number of the properties seeking information to be directed to the Council.

Another property has been identified in Arklow and approval is awaited from the department to consider this property under this funding scheme.

Bray Harbour Improvements: A tender will be issued when the URDF funding has been confirmed for the next phase of the project. A business case has been sent to DHL&H and a tender brief is being prepared for the procurement of engineering consultancy services to produce detailed designs, environmental reports and an application to An Bord Pleanala for the proposed works.

Tourism

Wicklow County Council Tourism Office continues to promote County Wicklow as a destination not only to domestic visitors but also on the international market using a range of tools and activities. See below some of the actions that were delivered during August and upcoming events for September:

PR Campaign: The extensive PR campaign being run by Wicklow County Council in partnership with Wicklow Tourism is proving very successful. To date, the campaign has secured 29 pieces on various media including print, digital, radio and TV. The PR value is estimated at €758,640. The traditional media reach is estimated at 6,146,600 while the digital reach is thought to be around 173 million. There is currently a competition running on the independent.ie with two more competitions planned in August and September on the RTE Guide print and digital editions.

Wicklow Passport: In July, focus has been given promote South Wicklow with a special itinerary around the villages of Carnew, Shillelagh, Tinahely and Aughrim. A short video was produced and promoted through the various VisitWicklow social media accounts achieving extensive reach and engagement. A similar campaign is planned for West Wicklow featuring stamping locations in Blessington, Hollywood, Donard, Baltinglass and Dunlavin.

Seasonal Stamps: Plans are being put in place to produce and promote seasonal stamps such as Halloween or Christmas Stamps. A special Tinahely Show stamp was produced and given to visitors wishing to start their journey around Wicklow.

Wicklow Outdoor Promotional Videos: Wicklow County Council has commissioned the production of a series of videos to showcase some of the great outdoor activities available in Wicklow. During the month of August, shooting will take place with a focus on Mountain Biking, Trail Running and Fast Hiking. Further productions will include sea swimming, equestrian, surfing and more.

Best Golf Holes in Wicklow: The first video showcasing the Best Wicklow Golf Holes has been shot and features The European Club. Over the next few months, the project will shoot a minimum of nine golf holes from various other Wicklow golf clubs. The objective of the project is to create content to help promote Wicklow as a world class golf destination.

Wicklow's Historic Gaol Operational Review

CHL & Associates have been appointed to conduct an extensive review of Wicklow's Historic Gaol. Commissioned by Wicklow County Council, this review will include the current tourism offering and identify potential quick fixes. This project will compare the Gaol with similar experiences nationally and internationally and identify opportunities and future developments.

Abbey Grounds, Wicklow

Work is progressing on the Fáilte Ireland Destination Towns project at the Abbey Grounds.

Glendalough Masterplan and Wicklow Visitor Orientation Study

Following from the launch of the Glendalough and Wicklow Mountains National Park Visitor Experience and Management Masterplan, work has begun on the implementation of the Plan. A Steering Group has been established, which is chaired by the Chief Executive of Wicklow County Council.

A Working Group comprising representatives from all stakeholders has also been formed and has commenced work on short term actions for 2024, along with longer term actions. As community

consultation and participation is a central tenet of the masterplan, a Local Advisory Group has been established to keep the local community informed and ensure their input to the process.

Improvements to traffic management and the additional car parking spaces provided with kind permission of the Brockagh Resource Centre and Laragh GAA have been welcomed by both visitors and locals alike. Directional signage has been erected to ensure an easier flow of traffic and this is supplemented by a dedicated social media campaign advising visitors where to access car parks.

Special Projects

Greystones Enterprise Hub: Work is continuing for the fit-out of the hub. It is expected to be ready for launch in the 3rd quarter.

Sites on Mill Road, Greystones: Progress on the Mill Road sites is on hold pending PRA confirmation of site registration.

Carnew Remote Working Hub: Preliminary drawings have been received with a final design agreement expected in mid-August. Where Part VIII planning permission is required, an application will be made before the end of the year.

Marketing Plan: MarketingCoach are working on promotional materials for the Marketing Plan for County Wicklow, highlighting the availability of Remote Working Hubs and Broadband Connection Points under the campaign idea "Choose Wicklow". The marketing campaign will begin late in September.

Offshore Renewable Energy

The Offshore Renewable Energy (ORE) Network continues to meet regularly and engage with the offshore renewable energy companies who are developing proposals off the coast of County Wicklow. A plan for 2024 based around three work-streams (skills, ports/harbours, and supply chain) has been agreed. A networking/information event for suppliers and other interested parties will be held in the 3rd quarter of this year.

Skills Strategy

The Skills Strategy for County Wicklow has been adopted and is available on the website to read. The Skills Taskforce will now begin implementation of the actions contained within the Skills Strategy.

Food and Beverage Strategy

Wicklow Naturally – Tinahely Show:

Once again, Wicklow Naturally was a key attraction at the Best of Wicklow tent at this year's Tinahely Show. The mobile kitchen entertained visitors with five food demonstrations by top chefs, including Catherine Fulvio.

Wicklow Naturally has also commissioned the production of short videos featuring the various Wicklow Naturally members. The videos will be featured on social media and the website. The project is to be carried out over the next 5 months.

By its nature TRACKS reverses the more usual model of inclusivity where a minority may be invited to join the normative group, quite often resulting in by-standing. Through finding the common denominator of 'wheels', this event created an opportunity for everyone to come together in a creative activity that reaches out across all ages and abilities and into every corner of the community.





The Wicklow Seed Ark is a self-sustaining project, and it thrives on the generosity of seed donations. If you take seeds from us, we ask that you return a portion of your harvest when your plants reach the end of their life cycle. This way, we can continue to grow and share this precious resource with the wider Wicklow community.




Sustainable SDG events presented by Students at Greystones Library

Talks

Local historian Therese Hicks presents a talk in Wicklow Library on the Wicklow Archives Corporation Minute Book project. The digitised minute book of the Wicklow Borough Corporation is now available to access on Wicklow.ie with resources at https://heritage.wicklowheritage.org/category/topics/wicklow-county-archives-service/wicklow-borough-corporation-collection. The minute book dates from 1662 to 1707 and is one of the earliest items in the County Archives. Written in the old secretary hand style, it has been transcribed into modern English and this transcription is also on Wicklow.ie. Local historian Therese Hicks produced the transcription for the County Archives along with an essay placing the minute book in historical context. The minute book opens a door into the world of Wicklow Town as it developed in the 17th and 18th centuries, detailing the proceedings of the meetings of the town burgesses. Outdoor Recreation

Wicklow Coast Blueway

The Wicklow Coast Blueway project is moving towards the second stage of the accreditation process with the current accreditation mainly reliant on provider-based activities. Blueway promotion, links and signage being developed with a Press release issued on the 19th July to our social media channels and to media outlets. Project completion due in March 2025, with signage works a priority and works currently at various stages of completion on the selected Blueway Nodes:

<u>Greystones</u> – Accessible boardwalk installed at South Beach. Works completed.

<u>Brittas Bay</u> – Accessible toilet, upgraded toilets, new larger water tank and new outdoor shower facilities. Car parking painting and tidy up. Works completed.

<u>Wicklow Town</u> –New outdoor showers, upgraded toilet facilities and path upgrading at Harbour area. Works are in progress until the end of August.

<u>Arklow</u> – New path completed replacing the old boardwalk at South Beach. Licence Agreement and MOU being finalised with Roadstone, landowner, with new facility works at the Cove to commence after the summer season, consisting of: installation of changing screens with seating area and a bike stand rack.

Speed Limits

New guidelines for managing speed limits have been announced. The initial proposal is for all rural local roads without an existing special speed limit in rural areas will be reduced from 80km/h to 60km/h, this is due to introduced in November with signage to be installed prior to that date. A tender for the poles (c. 420) for the required signage has been issued.

Noise Action Plan

The Wicklow Noise Action Plan is currently being assessed for SEA & AA. Public consultation will commence following this assessment.

The public consultation for Dublin Agglomeration Noise Action Plan (NAP) has been completed. This plan includes the majority of Bray town.

M11N11 Junction 4 to 14 Improvement Scheme

The Option Selection report was published along with Bulletin #11 on the project website <u>www.n11m11.ie</u> on 14 December 2021. The publication followed the review of submissions received during public display in 2021. Phase 3 Design and Environmental Evaluation was due to commence in Q1 2022. The scheme is currently suspended as no funding is provided. The Wicklow County Council project team are continuing to meet with the public and any interested parties.

M11N11 Bus Priority Interim Scheme

The BPIS seeks to achieve the early delivery of bus priority measures in advance of the main scheme between Loughlinstown Roundabout and Junction 9 (Glenview). The scheme is currently at the Options Selection phase (Phase 2 of TII's Project Management Guidelines).

A non-statutory public display on the emerging preferred options for sections A and C took place in November 2022.

A further non-statutory public display event was held in the Glenview Hotel in September 2023 that presented the overall emerging preferred option for the BPIS between Loughlinstown Roundabout and Junction 9 (Glenview).

The public display documents are available to view on the project website www.n11m11bpis.ie.

A significant negative response was received during the public consultation to the proposed closure of the N11 access to the Herbert Road.

Further environmental studies and traffic analysis have been completed on elements of the emerging preferred option. As a result, further consideration is being given to the preferred options at J8 Kilmacanogue, J7 Bray south (including Herbert Road access) and J6 Fassaroe (including the R117 access).

N11 Parallel Service Road at Kilmacanogue

A noise assessment to the east of the new Parallel Service Road Scheme was carried out during April and May 2022. The options review and design commenced in March 2023 following confirmation of funding from TII. Site investigation works were completed in November 2023. This information has been reviewed by the Design Team and the final design option has been prepared. Direct consultation has taken place with the affected residents/landowners. The procurement of a contractor for the construction works is currently being progressed by the project team.

N81 Knockroe Bend Realignment

Tenders for a Per-Cent Art Feature are being procured by the Arts Office. The preferred feature has been selected pending the completion of the final assessment stage.

N81 Irishtown West, Whitestown Lower, Hangman's Bend and Tuckmill Lower "N81 Four Studies"

Following completion of Phase 1 feasibility studies (The N81 Four Studies – Feasibility Report), Wicklow County Council are now progressing the following two projects:

- N81 Whitestown Lower Project; and
- N81 Hangman's Bend and Tuckmill Project.

The Phase 2 Options Selection work is currently progressing under TII's Project Management Guidelines. A non-statutory Public Display event on the Route Options took place in the Inis Fail Germaines, Main Street, Baltinglass, on Wednesday 27th March 2024. The public display documents are available to view on the project website www.N81whitestownandtuckmill.ie. The period for submissions ended on Friday 26th April 2024. The next steps are to further develop the options in order to establish the emerging preferred option.

N81 Pavement Capital Works

Drainage works and the resurfacing of 1km of the N81 between Tuckmill and Saundersgrove were completed in May 2024. Two other sections of the N81 received surfacing renewal works namely at N81 Trooperstown Blessington and N81 Mullycagh Lower. Works were fully completed by end May 2024.

N81 Hollywood Cross Rural Traffic Calming Road Safety Improvement Scheme (RSIS)

The Feasibility and Options report (Phase 2) was approved by TII in November 2023. The Design Report (Phase 3) was approved by TII in April 2024. The Part 8 statutory process (Phase 4) commenced on the 28th March 2024 with the period for submissions by interested parties ending on the 14th May 2024. At the May 2024 meeting of Baltinglass Municipal District the Elected Members voted to approve the Chief Executive's recommendation for the scheme to proceed. The Detailed Design and Contract Documents (Phase 5) are being prepared in advance of tendering for a contractor for construction.

Park & Ride/Share at Hollywood

A feasibility report, funded by the Baltinglass Municipal District was prepared and submitted to TII in Oct 2021. This report considered an option for parking accessed from the N81. TII subsequently provided funding to further examine the feasibility and options.

TII have indicated that they do not support the proposed additional access to the N81. As a result, the option for a parking facility accessed from the N81 has been discounted from the traffic calming scheme. Suitable parking locations, that can be accessed from the regional/local road network, are being investigated.

N81 Blessington Gateway Project

The Feasibility and Options report (Phase 2) was finalised and approved by TII in October 2023. TII have also approved funding to proceed with the design phase in accordance with TII Standards. Wicklow County Council are progressing this project to the design phase (Phase 3) to be followed by any necessary statutory approvals process (Phase 4).

N11/M11 Strategic Bus Park & Ride Facilities

Proposals for bus-based Park & Ride facilities are being progressed adjacent to the N11/M11 at Junctions 6 (Fassaroe), Junction 11 (Kilpedder) and Junction 16 (Ashford/Rathnew).

The Park & Ride at Junction 6 Fassaroe was approved by the Elected Members at the meeting of the full Council in November 2023.

The design for the Bus Park & Rides at Junction 11 (Kilpedder) and Junction 16 (Ashford/Rathnew) are being progressed in conjunction with the NTA Park & Ride Delivery Office.

Arklow Public Realm

The Parade Ground Public Realm works are complete on site. Following a meeting with DoHLGH, Project Completion Reports were submitted with additional funding requested in December 2023. The OGP Inflation Payment has been agreed with the contractor with payment completed.

Arklow to Shillelagh Greenway

We are in the final stages of Phase 2 Options Selection, which will determine the preferred route for the Greenway. The Draft Phase 2 Options Report has been submitted by the project consultant Roughan O'Donavon to the Roads

Project Office and is currently under review before submission to TII. Negotiations are still ongoing with landowners. Following completion of Phase 2 we will proceed to Phase 3, involving Design and Environmental Evaluation.

Baltinglass Town Centre Plan

Enabling works started in Baltinglass in mid-February with the WCC Direct Labour crew completing site investigation works and starting on utility works. The consultants are actively engaged in preparing final construction documents for the delivery of the town centre works.

Blessington Inner Relief Road

The current focus of the project is on the detailed design phase, including the preparation of associated documents such as the Compulsory Purchase Order (CPO) documentation. These efforts are crucial to advance the scheme towards obtaining statutory approval. Given the potential impact of the project on the Poulaphuca Special Protection Area (SPA), it is necessary to prepare a Natura Impact Statement (NIS) to assess and document any potential effects on the SPA. Once the detailed design and associated documents, including the NIS, are completed, the project will proceed to seek statutory approval from An Bord Pleanála.

Wicklow County Council Compulsory Purchase (Chapel Road Pedestrian and Cycle Infrastructure Improvement Scheme) No. 1 Order 2021

The Tender for the Chapel Road Project was issued on the 01st August 2024. On successful completion of the tender process construction is expected to start on site around the end of Q4 2024 / start of 2025. The CPO Notice to Treat was issued on all landowners in October 2023. There is active engagement between Wicklow Roads Project staff and landowners and a Wicklow County Council appointed valuer is engaging with valuers and homeowners as part of the CPO process.

Wicklow Greystones Greenway

The Phase 2 Route Corridor Option Report is currently under review. A 4 week public consultation was completed in May 2024 for the emerging route corridors. The project was presented at the April Council meeting with two public events taking place in Greystones and Wicklow during April. Meetings and information sharing is ongoing with Irish Rail for their East Coast Rail Infrastructure Protection Project. A meeting has been scheduled with Wicklow County Councils consultant Atkins Realis and Irish Rail consultant Jacobs for September to review the greenway coastal route option and its interaction with the existing rail line.

Blessington eGreenway

Under Section 177AE of the Planning and Development Act, we have formally submitted our planning documents to An Bord Pleanála. Given the need to conduct comprehensive additional surveys and generate a substantial volume of supporting material, An Bord Pleanála granted an extension to the submission deadline for additional information to January 29th, 2024. As this information has been deemed significant additional information by ABP we were required to undertake a public consultation period taking place in May and June 2024 for a 6 week period and are currently waiting on an update from ABP.

Projects under Construction

Bray Transport Interchange (Bray MD)

New plaza and public transport interchange in front of Bray DART station, with revised car parking, set down and taxi rank arrangements. David Walsh Civil Engineering has commenced works on site. David Walsh Civil Engineering commenced ground works in Mid-February. Main drainage works have been completed. Paving has been installed along Quinsborough Road and has commenced on Adelaide Road. Works are progressing on schedule.

Ballyguilemore Active Travel Facilities (Wicklow MD)

Provision of new pedestrian facilities and road safety improvements along the Ballyguilemore Road between Carrig View and the entrance to the proposed new St. Patricks GAA Pitch. The scheme includes for new footpaths and road widening works. Construction works are progressing well on site, with 400m of footpath completed and public lighting has been installed. Drainage and accommodation works are ongoing.

Arklow South Cycle and Pedestrian Scheme (Arklow MD)

Provision of 2.8km of segregated cycle track along the R-772 Wexford Road, Arklow between Knockmore Roundabout and M11 Junction 21. The scheme will also construct 1.4km approx. of pedestrian footpath. Footpath and cycle track on eastern side are largely complete with kerbing and base laid for cycle track on western side. Upgrade works have commenced on Knockmore roundabout.

Safe Routes to Schools: St. Kevin's National School, Greystones (Greystones MD)

Provide infrastructure for schools to increase walking and cycling as the preferred travel mode where possible and improve safety at front of schools. Front of school implementation works are completed. Works have commenced on the construction of the laneway linking the school to Church Lane.

Safe Route to Schools: Scoil Nioclais Naofa, Dunlavin (Blessington MD)

Provide infrastructure for schools to increase walking and cycling as the preferred travel mode where possible and improve safety at front of schools. This project includes implementing a one way system on the eastern side of Fair Green. Works have commenced on site.

Greystones Pathfinder (Greystones MD)

Provision of new and improved pedestrian and cycle links to Greystones Train Station. The spine route extends from Greystones Marina to Shoreline Sports Centre

Phase 1 - Church Road Improvement Works

This phase of the project will reduce vehicle speeds and provide a safer environment for pedestrians and cyclists along Church Road through the narrowing of the carriageway, junction realignment, new and improved pedestrian crossings and road resurfacing.

Phase 2 – Charlesland Dual Carriageway Roundabout Upgrade Works

The phase will include new and improved pedestrian and cycle crossings along the Charlesland Dual Carriageway. Tenders were invited for contractors to carry out the upgrade works. Tender assessment has commenced. It is hoped that a contractor will be appointed in September.

Phase 3 - Greystones Marina to Charlesland Pedestrian and Cycle Improvements

This phase includes the design of pedestrian and cycle improvement works to be completed along the public road linking Greystones Train Station with the Marina to the north and Charlesland to the south. The preliminary design has been prepared by Arup Consulting Engineers and has been issued to the NTA for comment.

Project Updates

Wicklow Active Travel Pathfinder Project (Wicklow MD)

Provision of pedestrian and cycle improvements along the R750 and Station Road to improve linkage to Wicklow Train Station. The Preliminary Design has been prepared by DBFL Consulting Engineers and submitted to the NTA for approval. Traffic surveys have been carried out and junction modelling is underway.

Wicklow Station Pedestrian and Cycle Link (Wicklow MD)

New pedestrian and cycle bridge to be provided at Wicklow Train Station, linking Station Road to the Port Access Road. Bus and vehicle set down to be provided along with cycle parking. Discussion is ongoing with the landowner on the purchase of lands for the construction of the vehicle set down/parking on the northern side of the rail lines. A design review is currently being undertaken and Part 8 report is being prepared for submission to the Council Members.

Safe Routes to Schools: Gaelscoil na gCloch Liath, Greystones Educate Together & Temple Carrig School (Greystones MD)

Provide improvements on Blacklion Manor Road to make the area safer for school children. These works aim to encourage more children to walk and cycle to school. Preliminary Design has been prepared and issued to the NTA for approval.

Kilcoole Road Footpath (Greystones MD)

Footpath to be constructed linking Greystones to Kilcoole. Meeting held with landowner to discuss accommodation works. A design has been prepared and issued to the landowner for agreement. Once the design is agreed a tender will be run to appoint a Contractor. It is hoped to begin construction in Q3 this year.

Bridge Rehabilitation (Local and Regional Roads)

Work on 3 new bridges was completed in June/July. Works "in-stream" has been completed at 2 locations on the Sally Gap

Winter Maintenance

The changeover to brine has commenced with fleet upgrades. Remainder to be tendered.

Surface Dressing

Works continued in June/July. 30 sites complete. 13 sites remain. Poor weather conditions have contributed to a slower output than normal.

Croí Cónaithe (Towns, Cities and Rural) - Vacant Property Refurbishment Grant

The Vacant Property Refurbishment Grant is a payment you can get if you are turning a vacant house or building into your permanent home or a rental property. The grant applies to qualifying vacant properties in cities, towns, villages and rural parts of the country.

A grant of up to €70,000 is available. If the refurbishment costs exceed the standard grant of up to €50,000, a top-up grant amount of up to €20,000 is available.

To qualify for the grant, applicants must:

Have proof of ownership or evidence of active negotiations to buy the property (that is, confirmation of engagement from the estate agent or owner of the property) where you are seeking approval in principle for a grant.

- Live in the property as your principal private residence or make it available for rent.
 - Have proof that the property has been vacant for at least 2 years and that it was built up to and including 2007.

Fire Service

Operational Fire Statistics July 2024

There were **67 incidents** attended during the month of July 2024. Due to laid down procedures to mobilise two stations to potentially serious incident types, individual Fire Stations were mobilised on a total of **85 occasions** including **4** mobilisations in other counties. On no occasion did an incident commander request additional resources over what was prescribed in the Pre-Determined Attendance.

Operational activity for the month of July 2024 **decreased by 24% (minus 27 mobilisations) on the preceding month** (June 2024: 112 mobilisations). There was a decrease in domestic house fires (-11 mobilisations) and a decrease in RTCs (-20 mobilisations). There was an increase in "false alarm good intent" calls where members of the public mistakenly alert the fire service in good faith (+8 mobilisations).

Operational activity for the month of July 2024 **decreased by 35% (minus 45 mobilisations) on the equivalent month in 2023** (July 2023, 130 mobilisations). Year on year there was a decrease in all types of buildings fires (-20 mobilisations), RTCs (-14 mobilisations), rural fires (-17 mobilisations) and malicious outdoor fires (-5 mobilisations) but there was an increase in false alarm good intent" calls where members of the public mistakenly alert the fire service in good faith (+13 mobilisations).

Examples of Incidents attended:

- 12/07/2024 Carnew and Tinahely crews attended a 2 vehicle RTC with patients trapped in a car.
- 27/07/2024 Wicklow town and Arklow crews attended an RTC involving an overturned car near the Beehive.
- 29/07/2024 Rathdrum and Tinahely crews attended a single car RTC in Aughrim.
- 30/07/2024 Greystones and Bray crews attended a domestic fire in Redford Park where 2 patients were treated for smoke inhalation.
- 31/07/2024 Wicklow town and Arklow crews attended an RTC involving an overturned car at Blainroe.

Incidents in County Kildare (3-incidents total):

- 05/07/2024 Dunlavin and Blessington crews attended a single car RTC at Silliothill, Kilcullen.
- 18/07/2024 Dunlavin crew supported a crew from Athy at a 2-car RTC with 5 potential casualties at Moone.
- 21/07/2024 Baltinglass crew were mobilised to an RTC at Knockcor.

General Update

- Following the appointment of a new Assistant Chief Fire Officer in June, a second Assistant Chief Fire Officer will join in September.
- New fire stations for Baltinglass and Dunlavin have proceeded to Part 8 Planning, following a presentation to Baltinglass MD on 22nd July 2024.
- 5 New Recruits completed and passed their training in Galway and Sligo during July and started in the service on 31st July in Rathdrum (1), Greystones (1), Arklow (1) and Carnew (2).
- 2 x 2-Day Emergency First Responder Refreshers took place in Blessington Fire Station (14 students).
- 3 x 1 day Emergency Traffic Management training took place in Greystones Fire Station (36 Students).

14 new residential houses and 18 Extensions were notified to LA for Commencement & 121 newly completed residential units plus 1 non-residential units were submitted, assessed and validated in July. There has been an increase in both Commencement Notice particularly in Opt Out Submissions and Certificate of Compliance on Completion submissions compared to the same period in 2023. As speed of construction increases with seasonal changes, CCC submissions increased in July.

BER certificates for all newly completed units were requested & submitted to Building Control as per S.I. No. 243/2012 - European Union (Energy Performance of Buildings) Regulations 2012.

Building Control continued with site inspections in July to identify non-compliances with Building Regs onsite and 2 Section 11 Compliance Requests were issued.

Revised Information requests remained high in July for both Commencement Notices and Certificates of Compliance on Completion, 72% of Commencement Notice submissions & 82% of Certificate of Compliance on Completion submissions required revised information. Revised information requests are issued to nominated role holders of submissions when compliance with Building Regs has not been demonstrated. Building Control have observed numerous Commencement Notice Submissions that are currently 'Revised Information' status on BCMS and awaiting validation.

Opt Out submissions are both extensions and single unit dwellings, generally from BCMS users who are unfamiliar with both BCMS and Building Regulations which leads to Building Control resources being directed to resolving both administration and technical issues with Opt-Out Submissions. Wicklow Building Control continues to perform rigorous assessment of submissions at commencement stage and onsite presence during construction. These methods remain the best way to promote compliance with Building Regs.




General Municipal Allocation and Discretionary Fund 2024
