
Subject Site:

A development site Circa 0.367 ha for **Therese O' Rorke** owner of Knockrobin Farm to seek planning permission for a single dwelling for her own personal use.

Submission Objective

My client, Therese O'Rorke, is the owner of Knockrobin Farm, including the farmyard and associated outbuildings. She now seeks to retain the proposed development site, outlined in red, for her personal use. The site is accessed via a private avenue with a gated entry, which is also within her ownership. Currently, Therese does not have a house of her own.

Therese's three sons, however, have already established homes in the area.

Michael O'Rorke resides at A67 FT96 (Reg. Ref: 13/8952; Folio WW34625F), Robert O'Rorke resides at A67 NN27 (Reg. Ref: 18/1179; Folio WW34567F),

David O'Rorke (WW34568F) previously obtained planning permission under Reg. Ref: 16/552 for a 3-bedroom family dwelling with a garage adjacent to the proposed site has made a separate submission Ref: DWTRLAP-093521 and is intent on seeing a planning for his future home at this location.

This site would if permitted complete a cohesive rural cluster for the O'Rorke family at Knockrobin reinforcing lifelong connection to the farm land and ensuring its continued use as a family homestead.

On this basis, my client seeks a zoning designation to RE - Existing Residential. We urge the Wicklow County Council Forward Planning Department, as part of the ongoing Local Area Plan review, to reexamine my client's lands and fully consider this proposal to adjust the zoning accordingly.



RN2 - New Residential - Priority 2




Modified Zoning to RE - Existing Residential
